# IX. NEW BUSINESS:

- A. Academic Senate Cross Disciplinary Faculty Retreat: Holly Jagielinski (Academic Senate Secretary/Faculty Co-Chair of the Planning and Institutional Effectiveness (PIE) Committee)
  - Holly reported PIE is looking at how information is being disseminated by the various committees on campus.
    - a. There does not seem to be communication across disciplines.
    - b. Holly met with Vice President of Instruction (VPI) Isabel O'Connor and Retired Dean of Institutional Effectiveness Madeleine Hinkes during summer 2019 regarding the issue.
      - The Classified Senate does a great job communicating information to the Classified Professionals.
        - \* Classified Senate Vice President Eva Parrill reported the Classified Learning Committee sends out communications regarding ClissiCon (Annual Classified Professionals' Retreat), maybe Faculty can do the same.
    - c. Holly would like to hold a Faculty Retreat after Convocation for Faculty to communicate across disciplines.
      - The agenda would be Faculty driven.
      - Immediate Past President Kim Perigo said it would be best for Faculty to meet after the spring semester Convocation since the fall Convocation has a bigger agenda.
      - Holly asked the Senators to share their thoughts.
        - \* Evan Adelson said it is a great idea.
        - \* Bruce Naschak agreed that the event should take place after Convocation and be a FLEX week workshop.
        - \* Alison Gurganus said the Convocation time should be cut in half to allow Faculty to attend the retreat.
        - \* Oscar V. Torres said Holly may want to check with Janae Johnson in the Mesa LOFT to find out if Hispanic Service Institution (HSI) funding is available to help fund the event.
    - d. There was a sense of the Senate to support a Cross-Disciplinary Faculty Retreat.
      - Parliamentarian Veronica Gerace reported a proposal needs to be submitted to the Senate Executive Committee.

- 1. <u>Reserved Textbooks Owned by Faculty</u>:
  - a. The Learning Resources Center (LRC) cannot accept textbooks to be placed on reserve after September 16<sup>th</sup> per the state of California. (We can accept additional Reserved Textbooks in January 2020.)
  - b. Reserved Textbooks will now be assigned Library of Congress Numbers.
    - The Library of Congress Number will allow us to find out if additional copies of a Reserved Textbook are available for students. (We only need the letters and the first three numbers of the Library of Congress Number to locate a book.)
  - c. Faculty who had their Reserved Textbooks returned to them will receive additional communication.
    The original cover letter with the returned Reserved Textbooks was not prepared by a Librarian.

- 1. California Community Colleges Board of Governors (BOG): https://www.cccco.edu/About-Us/Board-of-Governors
  - a. BOG will hold their Southern Region meeting in Riverside on September 16<sup>th</sup> and 17<sup>th</sup>.
    - The public can make comments on (Tuesday) September 17<sup>th</sup>.
    - Kim encouraged the Senators to encourage their department Faculty to speak out by sending a representative to the September 17<sup>th</sup> meeting.

- 2. <u>Mesa Guided Pathways</u>:
  - a. An inclusive process does exist for Faculty.
  - b. Please consider joining an Inquiry Group and speaking up during meetings.
  - c. The Senate Executive Committee will make sure your voices are heard.
- 3. <u>PIE Committee</u>:
  - a. Kim reported she attended the PIE meeting on behalf of Manuel Vélez when PIE discussed how communication is being disseminated by the Mesa College Committees.
    - Kim asked Chair of Chairs Terry Kohlenberg to ask the Department Chairs how their Faculty Members are currently receiving information and how they would like to receive information in the future.
      - Faculty needs to receive information from their Academic Senate Representatives.
- 4. Vote of No Confidence California Community Colleges State Chancellor:
  - a. Stakeholders need to know about the problems that currently exist in the California Community Colleges System.
    Attending the BOG meeting on September 17<sup>th</sup> will provide current information.

# G. President: Manuel Velez

- 1. Budget Deficit:
  - a. Tough times are ahead for us.
  - b. A "Hard Hiring Freeze" is now in place. (Please discourage your colleagues from resigning from the district.)
  - c. The 2019-2020 Mesa College budget deficit is \$4 million.
  - d. The 2020-2021 Mesa College budget deficit is \$5 million.
  - e. Mesa College can use the "Hold Harmless" clause for approximately three years to maintain our funding level.
    - Our enrollment will have to increase after three years.
    - The fall 2019 schedule has 5,000 fewer sections than the fall 2018 schedule.
  - f. We need to look at Enrollment Management:
    - VPI Isabel O'Connor supports the development of a long term Enrollment Management Strategy.
  - g. Mesa College Faculty can actively speak out against Campus Solutions and the New State of California Funding Formula for community colleges.
  - h. The Academic Senate for California Community Colleges (ASCCC) is currently not speaking out against the current State Chancellor for California Community Colleges.
  - i. The Area D for the ASCCC will meet at Mesa College on October 12<sup>th</sup>since the Mesa College Academic Senate is a member of Area D.
- 2. <u>Mesa Guided Pathways</u>:
  - a. Manuel reported he shares Faculty's concerns about the current Mesa Guided Pathways process.

- From now on we will not be sending hard copies of approved PAC paperwork; instead it will be scanned and emailed to faculty. We do keep hard copies of all signed paperwork on file in A117, as does the district compensation office.
