- A. President Rita Cepeda and Vice President of Instruction, Tim McGrath
  - Presentation to address the concerns of the academic senate in the development and formation of the Resource Allocation Committee (RAC).
  - Addressed the 5 issues that were brought forth to Presidents Cabinet from the Chairs and the Academic Senate.
  - Issue 1-The strategic planning consultation process was altered out of expediency. Assurance needs to be made that future consultation is provided and that it will ensure enough time is provided to allow for adequate input-a standard should be followed. The President noted that we need to demonstrate to accredidation committee that we have started a pilot program and are making progress.
  - Issue 2-Operational Guidelines for RAC were developed by Academic Affairs during 10/12 meeting.
  - Issue 3-Link between Budget Committee and RAC. RAC provides the opportunity to review data; looking at allocations from a program level to ensure that resources are allocated in an equitable manner. The Budget

- Committee deals with the larger budget picture (FTES, FTEF, Budget Expenditure, etc.).
- Issue 4-How will RAC impact the (supply) budget? This case needs to be made together.
- Issue 5- There needs to be an opportunity to video tape or view presentations so that others know what to expect/do. This is not a problem but that the presentations should be based on fact and do not need to be polished but rather put into the context of the whole college.

  - Math 46-catalog rights have made it more complex; evaluators have put Math 46 equivalency on hold in terms of students using 46 as an equivalent from other districts.
  - CRC is not responsible for determining minimum qualifications on who teaches a course-this needs to be done by discipline Dean and faculty before the CRC reviews the course.
  - CRC is reviewing "target audience" course descriptions to determine how important this information is and if it needs to be included.
