III. PROGRAM REVIEW COMMITTEE REPORT FOR YEAR ONE 2008-2009

IV. OLD BUSINESS

- RAC Updates Abbott read a resolution from the Council of Chairs declaring that they would not participate in RAC Stage 1, and an e-mail from President Cepeda suspending RAC until the Council of Chairs submit their own proposal for conducting RAC to ACAF. Abbott read his own statement regarding these actions, expressing disappointment that RAC Stage 1 was suspended after much work by ACAF and before faculty knew how it would operate. McGrath explained the background to his own expectations for RAC/integrated campus planning and thanked the members of the ACAF RAC subcommittee for their work. Discussion followed during which several members expressed dismay over the declaration of the Council of Chairs and the suspension of the RAC process already underway. Members also pointed out that the development of RAC Stage 1 carefully followed established shared governance procedures that had been approved by the Faculty Senate.
- Update on posting ACAF minutes on website Tovar has followed up with Dean Bergland's office and was referred to Steve Manzuk. Email has been sent to him.
- V. **NEW BUSINESS** was postponed due to a shortage of time.
- VI. **REPORT FROM ACADEMIC SENATE -** Abbott reported that two resolutions were passed: a Statement from Chairs on RAC and a Statement on Decision Making Processes. A third resolution was introduced by the Chair of Chairs regarding a Vote of Confidence on VPI McGrath.
