 - 1. Memorandum of Understanding (MOU) with Woodbury College for the Architecture Program:
 - a. A 2+3 Partnership which guarantees admission to San Diego Mesa College Students majoring in Architecture upon completion of specified criteria without the need for "Portfolio Review".
 - Students would complete a two-year program and Mesa and a three-year program at Woodbury and the MOU provides our students access to Woodbury's facilities.
 - b. This MOU is an update to previous long standing agreements between Woodbury College and San Mesa College's Architecture programs and represents the first formal renewal since 2006.
 - Mesa has the option of reviewing the agreement annually.
 - c. Juliette thanked Dean Zappia and Architecture Faculty for reviewing and updating the MOU.
 - d. Rob Fender reported the Architecture department's decade long relationship with Woodbury College has been beneficial to our students.

Second Reading

- 1. Manuel Velez said the resolution would hurt the current grant application process.
 - a. There are often extremely short deadlines for completing grant applications, sometimes as little as four weeks.
 - b. It would be extremely difficult to have enough time for a GRB to review some grants.
- 2. Terrie Teegarden said grants vetted by Faculty are thoroughly reviewed and do not require reviews by a GRB.
 - a. However, grants that the administration wants to pursue should be reviewed by a GRB.
 - We have run into problems with grants the administration pursued in the past.
- 3. Ron Ryno said we need to develop a clear definition of what the Faculty's interests are.
- 4. John Crocitti said the Faculty needs to receive reassigned time to serve the committee.

- A. Fashion Program Regrouping Proposal: (Susan Lazear)
 - 1. There is currently a proposal for the Fashion and Hospitality programs to move from the School of Health Sciences and Public Health to the School of Business, Computer Studies, and Technology.
- **B. Student Services**: (Guillermo Marrujo)
 - 1. Guillermo reported there are currently three District Student Counsel (DSC) resolutions.
 - a. The first would put more restrictions on our students' ability to remove bad grades.
 - The Mesa College Counseling Department is <u>opposed</u> to the resolution.
 - b. The second would alleviate all grades and credits, regardless of SDCCD or transfer coursework, as long as the course content is determined to be equivalent.
 - The Mesa College Counseling Department supports the resolution.
 - c. The third proposes that we accept all coursework from regionally credited institution regardless of their rating.
 - The Mesa College Counseling Department is opposed to the resolution.
 - * SDCCD should <u>only</u> accept coursework from regional institutions with "AG" ratings since these courses are transferable to four-year institutions, while coursework from "AP" rated institutions are not.
