## D. Curriculum Review Committee (CRC): (Co-Chair Toni Parsons)

- 1. <u>Transfer Model Curriculum (TMCs)</u>:
  - SB 1440 was passed by the California state senate approximately two years ago.
  - The law sets associates degrees at 60 units and bachelor's degrees at 120 units.
  - The law gives local community college students acceptance priority to their local four-year state institutions for students who complete similar degrees program as the four-year colleges.
  - There is real pressure right now for California State University (CSU) campuses to accept Transfer Model Curriculum (TMCs) for similar degree programs at community colleges.

- The Academic Senate for CA Colleges (ASCCC) tried to get Faculty from throughout California to meet and develop uniform degrees statewide for the state's 112 community colleges.
  - Please go to <u>http://c-id.net/</u> and click on TMCs to see the 22 finalized TMCs.
    - \* San Diego State University (SDSU) will accept all 22 TMCs.
    - \* Every TMC must have a list of core courses.
- SDSU will only accept students who completed TMC associates starting January 2013.
  - \* 80% of our students who transfer to a CSU transfer to SDSU, which means Faculty need to do everything we can to ensure that our students can continue to transfer to SDSU.
