SENATE RULES SAN DIEGO MESA COLLEGE ACADEMIC SENATE CONSTITUTION **ARTICLE I - COMMITTEE GOVERNANCE**

SECTION 1 - SENATE COMMITTEES:

The Senate shall have the following standing committees: Α.

- Senate Executive Committee 1.
- 2. Academic Affairs Committee
- 3. Academic Senate Equivalency Committee
- Committee of Chairs (COC) 4.
- 5. Committee on Committees
- Committee on Elections 6.
- Curriculum Review Committee (CRC) 7.
- Faculty/Staff Committee on Distance Education 8.
- 9 Learning Resource Center Liaison Committee
- 10. Professional Development Committee (PDC)
- 11. Tenure & Promotion Review Committee
- 12. Faculty/Staff Advisory Committee on Threats (FACT)
- 13. Other standing committees as may be specified in the Senate Rules

SECTION 8 - FACULTY/STAFF COMMITTEE ON DISTANCE EDUCATION:

Α. Composition:

- The Committee shall consist of:
- 1. A Faculty or Staff Chair, selected by the committee.
- Eight (8) Faculty and Classified Staff Members (At least one (1) Faculty member and at least one (1) Classified Staff member): 2.
- One (1) Administrator 3.
- One (1) Student Representative 4.
- The faculty online mentor (SDCCD appointed) 5.
- B. Duties:
 - The Faculty/Staff Committee on Distance Education shall be responsible for:
 - Alerting faculty to State and District online education policy matters. 1.
 - Providing a forum for discussing online instructional issues. 2.
 - 3. Directing faculty to resources that support best practices and guidelines in online pedagogy.
 - 4. Scheduling and advertising Flex presentations and other professional development opportunities for faculty and staff in the use of Blackboard, the progress of the State's Online Education Initiative (OEI), and other issues involving online classes and pedagogy.
 - Conducting periodic surveys of faculty and staff about the satisfaction level of online classes among students, faculty and 5. staff; advising the Academic Senate of any needed action with regard to Distance Learning.
