Agenda Item 5: New Business

1. Equity Plan (Larry Maxey, Vice President Student Equity)

Discussion:

Every 3 years, all community colleges are required to produce an equity plan that is intended to support the success of what we call disproportionately impacted students on our college campuses. This means based on the proportionate level of enrollment of a particular group. Let's say, African Americans. If African Americans were 10% of our enrollment at our institution and what we would expect to see continually year over year is at least 10% of the students who graduate or complete their certificate should or would be, African American. Thus African Americans would be having success proportionate to their level of enrollment. But what we are seeing is, and again, this is a hypothetical. 10% of our students are African American, and only 3% or 3 of them are continually having success.

For our campus, disproportionately impacted students are African American, Latinx, and Pacific Island. There are 3 things we want to focus on, 3 kind of overwriting ideas.

1. View the students from an asset based perspective.

- 2. View all of our work through an equity lens.
- 3. Committed to addressing and eliminating systemic barriers

Systemic barriers are those barriers that are inherently a part of a lot of processes. One example of that, the former Assessment Test. it will continually place marginalized students or students of color into lower levels of basic skills from which many of them never achieve success. We look at students from an asset based perspective. We assume that those students can and will be successful in college level courses if we provide the correct support to them, and that has proven to be the case. The year 1 and 2 goals, rather than focusing on a specific number or percentage. We simply said that we want to use year, 1 and 2 to rebuild community and set some belonging for those groups. So that allows us to engage in work that just says, hey, welcome back! Come back! We love you. We support you. Action steps we will continue to use the resources that we have to help our students to re-emerge out of the pandemic. We will continue to focus on race. We will continue to encourage and manage and train folks to be effective in their ability to communicate about race, and continuing courageous

leadership in conversations.
