# **ATTACHMENT #1**

Resolution of the Board of Trustees  
San Diego Community College District

**The San Diego Community College District Board of Trustees supports the travel restrictions identified in AB 1887.**

**WHEREAS**, the San Diego Community College District prides itself on a strong commitment to equity, inclusion, and diversity in the education of students and employment of faculty, staff, and administrators, without regard to race, ethnicity, heritage, national origin, immigration status, marital status, religion, age, gender, sexual orientation, gender identity, gender expression, genetic information, medical condition, or disability; and

**WHEREAS**, effective January 1, 2017, Assembly Bill (AB) No. 1887 prohibits California state-funded and state-sponsored travel to states that have implemented laws that authorize or allow discrimination on the basis of sexual orientation, gender identity, gender expression, same-sex relationship, or same-sex marriage; and

**WHEREAS**, this new law requires the California Attorney General to develop, maintain, and publish a list of states that are subject to the travel ban; and


**WHEREAS**, the California Attorney General has determined that certain states, including Alabama, Kansas, Kentucky, Mississippi, North Carolina, South Dakota, Tennessee, and Texas, and as may be further amended by the California Attorney General, are subject to the travel ban as these states have implemented laws that authorize or allow discrimination on the basis of sexual orientation, gender identity, gender expression, same-sex relationship, or same-sex marriage; and

**WHEREAS**, the travel ban restrictions set forth in AB 1887 apply only to state agencies, departments, boards, authorities, commissions, The California Community Colleges, the University of California, and the California State University, but may impact local public agencies such as the San Diego Community College District;

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Trustees of the San Diego Community College District hereby declares that San Diego Community College District funds and resources shall not be used to fund, sponsor, or support employee or student travel to states that are subject to the travel ban, with the exception of those situations specifically exempted in the legislation, as determined by the Chancellor.



## Update on Special Scholarship Support and Other Information regarding DACA Students

Dear Board Members and Colleagues:

I have received many requests to keep our District faculty and staff up-to-date regarding the DACA program. As you know, DACA is the acronym for Deferred Action for Childhood Arrivals, a program initiated by former President Obama to protect young people who were brought to this country as children, allowing them to study and work. President Trump has announced his plan to terminate the program altogether in six months unless Congress takes action to instate it officially through legislation. Meanwhile, we are working to ensure protections for our students and to urge Congress to take the necessary action.

We have also just received the following information and good news from the California Community Colleges Chancellor's Office:

Today Mission Asset Fund, a San Francisco-based nonprofit with a long history of supporting Dreamers, along with generous support from the Weingart Foundation, announced it is now providing \$495 scholarships so DACA recipients can safely renew their status. Any individual whose DACA status is set to expire between now and March 5, 2018, may still apply for renewal. The application deadline for these renewals is Oct. 5. Dreamers can apply for the scholarship at [LC4DACA.org](http://LC4DACA.org) and receive a check made out to the Department of Homeland Security within 48 hours. These grants are available to community college, California State University and University of California students. Please help get the word out to students about this resource as quickly as possible. A communications tool kit is available at the following [link](#). Please contact [programs@missionassetfund.org](mailto:programs@missionassetfund.org) with any questions.

Earlier this week, California Legislative Leadership and Governor Brown announced a deal to provide \$30 million to support California's undocumented immigrants. The proposal provides \$20 million in additional funding for immigration legal services under the One California program, and an additional \$10 million in financial aid for Dreamers in the California Community Colleges, California State University and University of California systems. CSU will receive \$2 million and UC will receive \$1 million to support the existing Dream Loan Program. The California Community College Chancellor's Office will receive \$7 million. This funding will be made available to local colleges so that they can provide emergency financial aid resources to students affected by President Trump's decision to rescind the DACA program. More details will be made available as enabling legislation and guidance becomes available.

On the legal front, last week UC filed suit in federal court against the Trump administration for violating the rights of the University and its students by rescinding the DACA program. On Monday, California Attorney General Javier Becerra, joined by the Attorneys General of Maine, Maryland and Minnesota, filed suit in the same federal court against the Trump administration related to the rescission of DACA.

The Chancellor's Office legal team is in contact with both the UC and AG and is exploring options to support their efforts.

We continue to provide updates on the "resources for undocumented students" section of our web site <http://www.cccco.edu/ResourcesforUndocumentedStudents.aspx>. Talking points in English and Spanish are available there, and translations into additional languages are forthcoming. Paid and earned media efforts are under way to remind undocumented students that our colleges continue to welcome and serve them and that financial aid is available through the California Dream Act.

We will be getting the word out to our students and we will keep you informed.

*A Resolution of the Classified Senates of the San Diego Community College District,

**THEREFORE, BE IT RESOLVED, THAT** the Joint Classified Senates of the San Diego Community College District shall henceforth refer to all classified personnel as “Classified Professionals,” or simply “Classified”; and

**BE IT FURTHER RESOLVED, THAT** we encourage the District to adopt the same practice, in recognition of classified professionalism.
