IV. Report from Academic Senate Meeting: May 7, 2018 (Howard Eskew)

A. Mesa College Full-Time Equity Librarian Edeama Onwuchekwa:

- 1. Edeama reported she has met with Black Studies Chair Thekima Mayasa and she will meet with Chicano/Chicana Chair Manuel Velez regarding materials available through the Learning Resources Center (LRC) for students in their programs.
- 2. Librarians Department Chair Alison Gurganus reported their will be a Student Equity Survey.

B. Guided Pathways (GP):

- 1. There will be one more Task Force meeting for spring 2018.
- 2. There will be GP work during summer 2018.
- 3. The Task Force will become an Operational Committee.
 - a. There will be eight (8) Faculty members. (One from each school.)
 - b. There will be three (3) Administrators. (One will serve as the Administrative Co-Chair.)
 - c. The Operational Committee will have subcommittees.
- 4. Mesa College needs to find funding sources to sustain GP programs after the state ends funding.

C. Resolution: Vote of No Confidence – State Chancellor: Absence of Consultation

- 1. Mesa, City and Miramar Colleges and our Continuing Education Academic Senates approved the resolution.
- 2. Glendale Community College and College of the Sequoia also approved a vote of no confidence.

D. Resolution 18.5.1: Constitutional Change – Senator at Large:

- 1. We did not have a candidate for the position during the spring 2018 election.
- 2. The resolution temporarily changes the constitution for one year to allow tenure-track Faculty Holly Jagielinski to serve as Senator at Large for one year.
 - a. Tenured Faculty Alison Gurganus will serve a two-year term as the other Senator at Large.
- 3. The rules were suspended and the resolution was approved today.

E. Resolution 18.5.2: Constitutional Change – Career Technical Education (CTE) Committee:

- 1. The Strong Work Force Committee Faculty Co-Chair/Statewide Liaison will receive .2 reassigned time.
- 2. The Academic Senate cannot have a say in the resource allocation process.
 - a. A Strong Work Force Ad Hoc Committee will determine funding allocations.
- 3. There will be a discussion and potential vote during the September 10, 2018 meeting.

F. Resolution 18.5.2: Creation of the Fine and Performing Arts Committee:

- 1. The resolution will create a "Think Tank" for the Art, Dance, English/Poetry, Fashion and Music departments as part of the STEAM (Science/Technology/Art/Engineering/Math) initiative that started last year.
- 2. The committee would report to the Academic Affairs Committee.
- 3. There will be a discussion and potential vote during the September 10, 2018 meeting.
