The Student Success Teams project team is reviewing the results of the Student Success Teams Interest Form/Survey which will inform what ACP will be piloted as well as the composition of the SST.

- A. Committee of Chairs: Wednesday (April 27, 2022)
  - 1. Bryan Malinis:
    - a. Donna Budzynski's presentation on enrollment trends since 2014.
      - Mesa College was experiencing a downward trend in our enrollment before the pandemic began.
        - \* The report provides food for thought for our enrollment planning.
    - b. The district is working with UCSD and other local institutions to review our current Covid 19 Protocols.
      - Chair Oscar V. Torres said it seems like institutions want to make it possible for more Students to enroll in their classes.

## **B. President's Cabinet Retreat**: Tuesday (April 26, 2022)

  - a. The event was well attended.
  - b. The National Assessment of Collegiate Campus Climates (NACCC) was in attendance.
    - The NACCC developed a report for Mesa College.
      - \* The report has interesting findings that are particular to Mesa College.
      - \* 68% of Mesa Colleges Students are female.
      - \* How Students of Color feel when they are in a classroom with a White Professor? (They are less likely to feel that they receive affirmations from a White Faculty Member.)
      - \* How can Mesa College make our Students of Color feel more welcomed?

# C. Senate Executive Committee: Monday (May 2, 2022)

    - Mary Gwin said we will have to follow district policy.

#### 2. Mary Gwin:

- a. Requirements for Distance Education/Online Class Attendance:
  - District Dean of Student Services Victor Devore:
    - \* "The Student must "actively participate" and we must be able to have documentation of such participation.

Here's the regulation:

In a distance education context, documenting that a student has logged into an online distance education platform or system is not sufficient, by itself, to demonstrate attendance by the student.

To qualify as a last date of attendance for Return of Title IV purposes, an institution must demonstrate that a student participated in class or was otherwise engaged in an academically related activity, such as by contributing to an online discussion or initiating contact with a faculty member to ask a course-related question. (34 CFR 668.22(b) (3))."
