5) Fall 2021 Enrollments.

It is no secret that enrollments, for Mesa College, is low this semester relative to previous years. This negative trend is in line with that of other community colleges across California. There are many reasons why enrollments are low, which I will not discuss here. Locally, instructional chairs and deans are in continuous communication in regards to enrollments and course offerings, as evident by the Deans Council held 8-5-21. Currently, the main point of discussion is course cancelations in response to the low enrollments. These decisions are most likely to significantly impact our adjunct faculty, students, and program growth. To the best of my knowledge, and please feel free in providing additional information, the current plan is to monitor our respective on-going enrollments week by week, without making any rushed decisions. Nonetheless, knowing the CBA and POA rules as well as guidelines is going to be important within the following weeks. To say the least, given that every program is indeed unique regarding class caps, number of classes with multiple sections, as well as course offerings, and schedules, it is my understanding that establishing a broad criteria for cancellation across the board is difficulty. According to an email sent out to department chairs by our VPI, there seems to be a pivot towards scheduling short-term courses within the 10 and 12 week timeframes. Additionally, redistributing FTEF to the spring, or intersession are also ideas being discussed. Class cancellations for the fall are thus expected during the week of August 16-20th. I, personally, suggest that the Data dashboards be used when considering previous enrolment trends, fill rates, and success outcomes in relation to cancellation decisions.

6) Fall 2021 Vaccinations

I have received questions regarding vaccination. To the best of my knowledge, COVID-19 vaccinations are, currently, not required for employment as SDCCD. What is required is for employees to report their current vaccination status by submitting one of two Forms in response to Vice Chancellor of Human Resources Gregory Smith's email. The information is to be provided via the "Employee Dashboard". I have the example forms in case anybody needs them. It is possible to be exempt from vaccination. During our most recent Campus Community Forum, July 13, 2021, Lorenze Legaspi, VPS, states that faculty members their offices, and campus classrooms teach use use (15:07), https://www.youtube.com/watch?v=aU4JUiDfmAI. However, I still recommend reaching out to respective Instructional Deans for more information as everything changes from week to week. Face coverings are mandated at all district sites except when you are alone, outdoors, 6 feet away from everyone else, eating or drinking, or performing work-related duties that cannot be done safely while wearing the mask. No social distance requirement are mandated while wearing a mask, but encouraged when possible. Students, who enrolled onto F2F class, are required to upload proof of vaccination, or they will be dropped from the course. The deadline for students is this Friday, 8-6-21. Students will not be dropped from classes for non-payment reasons, as stated by an email sent by Vice Chancellor of Educational Services Susan Topham.

7) Committee work

Finally, regarding our committee work, we still have to input some of the changes provided by the DE committee onto our Academic Integrity paper. I would like for this to be done by the first Senate meeting, so that it may be voted on. Second, I have invited a student representative from Associated Student Government to attend, as a guest, our first Academic Affairs meeting, 8-30-21. I have not yet received a response, but will let you know. We are still in need of a faculty representative from Fine Arts, an adjunct member can also serve. I believe Credit for Prior Learning will be a topic for discussion through the semester. We must re-check our Academic Senate constitution, to make sure that our voted-on changes have been updated. We should also receive a small report from any sub-committee we might still be responsible for and note this for structural purposes. Regarding our minutes, I will send everyone a copy of minutes from last semester to be approved by our committee. Lastly, for our August 30th meeting, I know that Monday will be probably be a long day for most of us, thus I plan on keeping the meeting short.
