V. Guided Pathways Report: Alioto

As reported by Marisa Alioto:

<u>"Mesa Mapper:</u>

Mapping is underway! To be in compliance with AB 928, a team of counselors has prioritized and is currently working on providing preliminary updates to ADT maps in preparation for a review process with faculty members, which will take place in March. An update of maps for all local programs and certificates will follow, in consultation with instructional faculty, to reflect curricular updates.

Counselors completed initial drafts of Associate Degree for Transfer (ADT) maps by their initial February 29th deadline and will be reaching out to departments to coordinate next steps in the mapping process to move toward finalizing ADT maps by June 1, 2024. Counselors will be moving toward completion of drafts of the next 30 local AA/AS and certificate degree maps by

April 3rd, 2024.

Mesa Mapper Implementation Update presentations are currently in progress. So far, we have provided presentations to: Dean's Council, Committee of Chairs, PIE, Classified Senate, Associated Students, CRC, and Counseling.

Upcoming presentations are currently planned for Academic Senate, PCAB, MSSC, and Academic Affairs.

Mesa Success Coaches (MSC):

The Mesa Success Coaches are continuing into their second semester. Coaches reached out during Flex week and with a reminder about the add/drop deadline. Coaches cohorts will begin meeting again in March. A mid-year report on the impact of the program has also been generated by Institutional Effectiveness.
