 - d. But people are tired by June, so maybe offer this twice?
 - i. Or maybe early May? A follow-up date to see "have you applied what you learned, how is it going?"
 - ii. Or maybe during Fall flex week? This would provide consistency
- IV. Professional Learning INTEREST Form
 - a. We received a request for funding from AFT for the Summer Institute, requesting \$1200 (June 2-5)
 - i. This is held at City College this year, last year it was held at Mesa
 - ii. AFT has funding for Professional Development

- iii. We are in a tighter budget, we may want to prioritize funding activities that are specific to our campus
- iv. Andy submitted a motion to approve the funding
 - 1. No one seconded the motion
 - 2. The motion failed, the committee does not approve the funding
- b. When we have outside groups hold their PL at our campus, can we "rent" our facilities to them- this could help us fund more PL on campus?
 - i. This may not apply to AFT, since employees are members of this organization

 - i. SITE copies were shared by El Camino College. They provide an application to support small inquiry teams or communities of practice with an end of the year showcase.

 - a. Hands on training in technology- confer zoom, canvas workshops, videos
 - b. 4 days, themes for each day
 - c. Online offerings, half are online, half are face to face
 - d. After opening day session, people have options for sessions, basically a mini-conference, and follow-up throughout the semester
 - ii. Right after convocation, have a mini-conference, everyone is already on campus

- iii. Currently, the time after convocation is reserved for COA, but COA could be part of the mini-conference, or COA could have their workshops a different day
- iv. Proposal to Prez. Pam- what should be in the proposal?
- v. Support PL during Flex week Discussion
 - 1. Offer more opportunities during Flex week instead of administrative meetings
 - 2. Have more department-driven PL (grassroots)
 - 3. An overarching theme- Work with the Prez. Pam to determine the theme early
 - a. Back to the future/ 1920-2020
 - b. Luau
 - c. Election/Voting
 - 4. Something about each individual's value in the overall institution
 - 5. Continue the idea of brave discussions (from Tim Wise's speech)
 - a. or focus on Communication within departments, across departments, etc.
 - b. or something about Mesa 2030 or Guided
 Pathways related where do you see us heading?
 - 6. Mark- There is a framework for the program, each semester take 1 word from the framework, to do a deeper dive
 - a. For example the word "noticing"
