- The sub group reviewed the pilot ILO Assessments that were returned by the DOCs. Discussion is ongoing.
- It was suggested that, for the ILO Assessment, the committee follow the template of the graduate survey and create something that could be distributed through Canvas.

 - o The survey could be administered throughout the semester.
- As there are different ways critical thinking is defined across disciplines, it was suggested that each school be responsible for assessing the Critical Thinking ILO.
