Note: You must sign up by Thursday at 11:59 p.m. to have your direct deposit take effect for financial aid disbursed that week. This deadline may change if holidays take place on Fridays.

If you do not wish to sign up for direct deposit please be advised disbursements will be processed in the form of a paper check mailed to you via U.S. postal mail.

It is important that you verify your current mailing address by logging into your mySDCCD account at http://my.sdccd.edu.

You do not need to be enrolled full-time to receive Financial Aid but if you enroll in less than 12 units, your actual award will be reduced or canceled depending on the program requirements. Your Pell Grant payment will not be further adjusted if your enrollment level changes after the census date, unless you do not attend or drop any late start class before the first day of classes. However, you must enroll only in courses that apply to your academic plan to maintain your aid, and you must be enrolled in all your classes including short term classes by the semester census date in order for the Pell Grant to pay for those classes.
