 - CVC defines "committing to" to mean that the process has been started by the college/district and is in progress.
- Title 5 section 58146 intent:
 - Districts should not lose FTES apportionment as a result of an emergency or extraordinary condition.

 - ✓ is a member of the CVC-OEI Consortium and has signed the Master Consortium Agreement.
 - ✓ by the beginning of the first term that starts on or after January 01, 2023, has implemented the steps to become a Home College and has implemented or committed to
 - enabling Course Finder API
 - completing the steps needed to become Teaching College ready, and
 - joining a scheduled implementation cohort to become a Teaching College.






College Implementation Tracker (cont'd.)

- ✓ Join the CVC-OEI Consortium: Sign the Master Consortium Agreement and email that document to <u>support@cvc.edu</u>.
- ✓ Become a Home College on the CVC Exchange: This means that a college has completed the technical steps to allow its students to take cross-enrollable courses at Teaching Colleges on the CVC Exchange.
- ✓ Federal Financial Aid Consortium Agreement: Once signed, your college's students can request federal financial aid and combine units across colleges
- Enable the Course Finder API: Will ensure that colleges have their live seat counts reflected on the CVC Exchange.
- Become "Teaching College Ready": The additional steps needed for districts to become Teaching College ready (meaning being ready for Teaching College technical integration) are: (a) <u>enabling sending of etranscripts</u> through eTranscript California and (b) <u>enabling Super Glue</u> with the CCC Technology Center.

Student website will be created by Susan, Jess, and Carol


Educational Services will provide each of the colleges with the faculty and student website links so they can be included on the college websites.

Working on creating a website for faculty and staff that can be added to our websites and will be housed by the district Two letters, one to go out to students and one for faculty that has links to all the pages and will go out closer to the launch date Still have issues with students not being enrolled in the home campus and able to enroll for CVC OEI courses






Brian's Updates

- Looking to test the search match
- Double check for duplicates
- First name, last name, and DOB, we will not do their CCC ID initially
- They will be provisioned an sdccd.edu email address
- How do we handle the accommodations? Is it handled by the home college or transmitted to the district
- Reaching out around March, early April, late March
- They will have a CVC service indicator
- Can only add and drop classes from CVC
- Admissions, FA, and Counseling will have access to service indicators
- They will have a hold because they won't be able to apply for financial aid at the teaching college because they have a home college where they can apply
- Add and drop needs to be done through CVC and not CS
- Refund needs to be manually done

Brian's Updates



- Connecting Canvas Integration
- When students entering home college login, when they click on the tile in the exchange, it will load the teaching campus' hub
- When students login to Canvas, they just click on the tile for the class
- Concerns about proctoring
- Badges appear on the search
- Our SDCCD students taking classes regardless of whether they are through the exchange or not
- 100% online, after open enrollment
- Students can enroll
- Right places, right prerequisites showing up
- 8,000 students have gone through the exchange

Others

- Testing started
- Communication will go out mid-March
- Will give DGC a heads up
- Will align with summer and fall registrations
- POCR Aligned, hoping to be done by the end of the semester to get a badge
- 2 courses limit on the exchange

Dear SDCCD Community,

San Diego City, Mesa, and Miramar Colleges are becoming California Virtual College (CVC) Exchange Teaching Colleges. This transition increases students' access to higher education statewide by streamlining the registration process for our online classes, ultimately bolstering enrollment figures.

A dedicated cross-functional team, comprised of CVC leads from San Diego City, Mesa, and Miramar Colleges, along with District Educational Services and IT, has been hard at work for several months to make this transition possible. With the final implementation and testing phases underway, City, Mesa, and Miramar Colleges are scheduled to go live as a Teaching College on April 29, 2024.

Here's what you need to know as we approach this milestone:

- Courses labeled as Zero Textbook Cost (ZTC) in our class schedule will be prominently badged by the Exchange. These classes receive priority placement in the CVC search algorithm and tend to fill up quickly. For guidance on incorporating Open Educational Resources (OER) and achieving ZTC status for your course, visit the <u>OER Faculty</u> Resource Course.
- · Late-start or short-term classes are particularly popular for cross-enrollment.
- Students across the state seek courses in all subjects. The only courses that are
 visible on the exchange are the courses that are fully online and do not have an "inperson" component.
- To ensure that our students have priority, students enrolling through the exchange may only enroll during open enrollment.
