Parker reviewed with the committee the articulation handouts on the Transfer and Articulation Committee (TAC) resolution which encourages community college senates to adopt the California Community College General Education CLEP (College Level Examination Program) and the International Baccalaureate (IB) list for general education (GE) exam equivalency. The goal is for California Community Colleges to align the award external exam credit with the California State University. The Advanced Placement Exam list was previously approved by the ASCCC this past spring.
- * The Catalog Subcommittee review of the non-curriculum section was completed on November 18, 2010 but AUOs/SLOs can still be updated. J. Parker stated the AUO/SLO changes must be entered into TaskStream first and then submitted for catalog revision.
