Objectives of the Taskforce 22/23

Original: Create a student -centered schedule that is predictable, responsive, efficient, and supports student success, completion, and equity outcomes.

Updated to also include: Approach enrollment management with an intentional focus on the FTES, Supplemental, and Student Success factors of the Student -Centered Funding Formula (SCFF).

- Accomplished by the work of ightarrowover 75 people from across the college, in 7 subgroups.





Headcount and Productivity



Key Findings from Environmental Scan

- By 2030, District wide population growth projected
 - 20-24 ages ~16% and 25-29 ages by ~28%
 - Latinx and AAPI also projected to increase
- By 2025-2026, ~5% projected decrease in SD County high school students
- Reasons affecting student enrollment decisions
 - Prioritizing work
 - Affordability, modality, mental health, and dependent care
