1) CALL TO ORDER: Vice President, Instruction, Isabel O'Connor

2) PRESIDENT'S REPORT

a) Campus Updates: Vice President of Instruction, Isabel O'Connor presided over President's Cabinet on behalf of Dr. Luster who is at San Mateo College serving as the Chair to the Accreditation Site Visit Team. VPI O'Connor shared that there is a site visit to Mesa College tomorrow with the principal fiscal and policy analyst, Edgar Cabral, from the Legislative Analyst's Office (LAO). This visit is in preparation of the Bachelor's Degree Program LAO report which is due February 1, 2020. Mr. Cabral will interview district staff, including Chancellor Carroll, as well as VPI O'Connor, Tina Recalde and faculty of the Baccalaureate degree program. In addition, Mr. Cabral will also interview members from the advisory board and baccalaureate students who are employed in the HIM field. VPI O'Connor thanked Patty Garcia who assisted in the preparation of reports and spreadsheets for the expenses related to the baccalaureate program. The goal is for the HIM pilot program to continue and become a permanent degree.

Andy MacNeill and Leticia Lopez shared they submitted a proposal for an extension of the National Science Foundation (NSF) STEM grant for \$50,000 and have been notified it was approved. Andy MacNeill stated this grant compliments two other partnerships that Mesa College has with the San Diego Unified School District and a subcontract grant with SDSU as part of the *Developing Effective Bilingual Educators with Resources (DEBER)* project designed to facilitate teacher education for bilingual students pursuing an elementary, middle or high school teaching credential.

b) President's Cabinet Fall Retreat: VPI O'Connor shared that the date of the President's Cabinet Retreat is Tuesday, Oct. 29, 2019, 1:00 – 5:00 p.m. (room TBD). One of the main focuses of the retreat will be the Master Plan.

6) OPERATIONS

Standing Items:

a) Enrollment Report: VPI O'Connor shared the FTES is 5,907 and we have exceeded by .7% of target which was 5,866. District-wise, the credited colleges combined are at 95% of the fall target. Headcount is 20,974, which is about 1,700 less than a year ago.

In terms of the fall semester, the high school applications are in; VPI O'Connor stated it was a bit of a "bumpy road" due to CCC Apply which was new to the students and some sites are more proactive in terms of completing paperwork. Dr. O'Connor thanked Ailene Crakes, Vicki Miller and her staff, Susan Topham and Gerard Collins.

The Annual Principal's Roundtable breakfast meeting will be held this Friday and a discussion will be held on how the high schools administrators view Mesa's role to their programs in terms of dual enrollment.

The fall enrollment efficiency is at 14.22 – which is 2.4% up from a year ago.

Dr. O'Connor stated Mesa is now inputting schedules for intersession and spring. Intersession is mostly finalized by the Chairs/Deans; spring is close to being finalized. The intersession is looking very much like last year and

will be mostly online classes.

b) Mesa Pathways: Howard Eskew, Mesa Pathways Co-Coordinator, stated they have begun the process of reviewing and updating the Mesa's Guided Pathways Essential Practices: Scale of Adoption Self-Assessment. An email will be sent for recipients to review and provide input. The document is due to the State by March 31, 2020, however, it must be returned for final review by President's Cabinet by the end of this semester to make that deadline.

Howard shared the workgroups Guided Majors and Mapping have hosted two Mesa Mixer events bringing instructional and non-instructional faculty together for cross-disciplinary discussions and to continue the program mapping work. Brave Communications work group will be hosting a FLEX Event on Friday, October 18th on the topic of what language should we use when communicating with students. Additional FLEX activities are planned for November and December.

Six more Mesa Mixer events are on schedule; Alison Primoza and Michael Harrison have developed a new program for the next Mixer on October 9, 2019.

Howard shared the following activities:

October 9-11 a team will be sent to the Strengthening Student Success Conference.

October 24-26, 2019 "Leading from the Middle" is going to their final convening and will report on how some of their purpose has been restructured.

November 1, 2019, a team from the ASCCC to speak on Sustaining Guided Pathways through Governance Processes.

November 22, 2019, at Imperial Valley College, ASCCC will hold their Guided Pathways Regional Meeting. This is an open invitation to all on campus.

Howard presented on Mesa Pathways Workgroup "shells" that are being developed in Canvas format by Katie Palacios. The four work groups are Guided Majors and Mapping, Proactive and Integrated Student and Academic Support, Brave Communications and Onboarding and Career Exploration. The workgroups will each have a link to their section so that all may review and share comments/concerns.
