7) OPERATIONS

a) Instructional Updates: Isabel O'Connor, Vice President of Instruction, gave the following updates:

1) Monday was the start of the second, 8-week courses which are heavily enrolled. Headcount is 19,654. All of the indicators are going up and that is thanks to the

great work.

- 2) Spring 2024 has been completed and now working on fine-tuning. November 6 is primetime.
- 3) Dr. O'Connor attend the New Classified Institute (NCI) on Friday and it was a great experience.
- 4) Last Saturday, October 14, there was a Solar Eclipse event that took place on the Mesa Quad. It was exciting to see people of all ages come to the event and enjoy the many interactive ways to view the eclipse. Thank you to Dean Jennifer Carmichael, Physical Science Chairs Dr. Irena Stojimirovic and Dr. Jennifer Snyder, Physical Science Instructors David Coleman, Dr. Scott McCartney, Walter Thompson, and ILTs Chris Waters, Michael Lewis, and Alex Beltzer-Sweeney. We appreciate all your hard work.
- 5) Faculty will be presenting at conferences; these include aligning pedagogy and workforce.
- 6) Congratulations on receiving the provisional approval for the second baccalaureate degree program at San Diego Mesa College. There are additional steps with ACCJC and then it will go to the Board of Governors for vote and status will be received between January March 2024.
- 7) Governor signed SB444 on October 13, 2023; this bill encourages community colleges to develop and implement Mathematics, Engineering, Science, Achievement (MESA) programs directed at identifying students affected by social, economic, and educational disadvantages, increasing the number of eligible students served under MESA programs, and increasing student success in transferring and completing baccalaureate degree programs in science, technology, engineering, and mathematics majors at four-year higher education institutions, as specified. This bill puts the program into the California Education Code so that we have a greater chance to stabilize funding for the M.E.S.A program at Mesa College to open a M.E.S.A. Center and hiring a director.
- 8) Curriculum changes are coming which involves how to incorporate Cal-GETC with ADTs; and also Ethnic Studies requirement(s) for GEs.
- 9) Isabel will be in Sacramento tomorrow for the (CCN) Common Course Numbering Taskforce meeting and there will be one more in December and then there should be a final draft of the recommendations.
- b) Student Services Updates: Larry Maxey, Vice President of Student Services, shared the following updates:
- 1) The District Student Services has developed a draft of the Student-Centered Funding Formula (SCFF) tool that will allow us to capture the data associated with the SCFF data which is important to funding model. The supplemental portion is the part where we are the most lacking in terms of being able to ensure that we get the most funding associated the SCFF formula. The data

tool covers and focuses on students who qualify for AB540, California College Promise Grant (CCPG), Pell Awards, and students who have completed the FAFSA verses those students who have not. Currently, 44% of our students have completed the FAFSA or some form of AB540 application or CCPG. 90% of the students that complete the FAFSA are awarded some funding. This gives us the opportunity to focus on the data and develop strategies that will help us to improve our numbers.

- 2) October 18, 2023 is the Pep Rally and we look forward to supporting our athletes and community.
 3) Student Health continues to host a reflection table outside of Student Health Services I-400 building, Room 209. People may leave thoughts, feelings, and reflections concerning the war in the Middle East. Mental Health is hosting "The Healing: Empowering Minds with Derrick White and Black Leadership Fellows" on Wednesday and has a Parent Group led by Derrick White, LMFT on Thursday. VPSS Maxey shared that there has been a 300% increase in mental health services that have been offered through our Health Services since we hired Derrick White.
- 4) The Dreamers Resource Center and Borderless Scholars invites campus community to join us for the 7th Annual Undocumented Student Action Week happening all this week including workshops, events and collaborations with Region Ten community colleges and universities.
- 5) This month the Pride Center celebrates LGBTQIA+ History Month with a number of activities and programs. 5) Disability Support Programs and Services (DSPS) October is National Disability Employment Awareness Month and excited to invite all to participate in several exciting activities to celebrate advancing access and equity.
