<ul> <li>2) PRESIDENT'S REPORT</li> <li>a) District and Campus Updates: President Ashanti Hands gave the following updates:</li> <li>1) Dr. Hands thanked those involved with the District- wide Job Career Fair. There were over 100 employers and over 700 students from throughout our region. Dr. Hands stated she observed three young men being hired on the spot.</li> <li>2) President Hands stated she attended the Powwow event; it was the first Powwow in over 30 years at San Diego Mesa College. It was held in partnership with San Diego Mesa College. It was held in partnership with San Diego Inified School District.</li> <li>3) VPI Isabel O'Connor shared an update on the proposal for a second Baccalaureate degree – Physical Therapy Assistant. It was given conditional approval and then Cal State San Bernardino had some objections about the potential duplication and the proposal has been stopped from progressing. VPI O'Connor stated they had a meeting with the State Chancellor's Office last week and they explained about moving the proposal forward in three steps. The Research and Planning group at the State level is completing an analysis of the potential duplication. They will send that document and then after the review, Mesa College will perhaps decide to make some changes/adjustments or decide to move it forward. The R&amp;P analysis as well as SD Mesa College's response will be shared by the Chancellor's Office with Cal State San Bernardino. CSSB will have 30 business days to reply, and if there is no opposition, then we would be good to go to the Board of Governors for approval. If CSSB does not agree with our response, then the Chancellor's Office is in the process of looking at an additional step of having a 3<sup>rd</sup> party look at SD Mesa College side, CSSB response, and then arbitrate those differences.</li> <li>4) Dean Vicki Miller shared that SD Mesa College has a Jack Kent Cooke Foundation Scholarship semi-finalist, Husna Ayoubi. <ul> <li>a) Instructional Updates: Vice President of Instruction, Isabel O'Connor, gave the following updates:</li> <li>1) Next week VPI O'Connor will be attending the CIO conference and will be presenting with Dean Jennifer Carmichael at the pre-conference session. Isabel will also be attending the APAHE conference.</li> <li>2) Enrollment update: We have now started the second 8-week courses and it looks strong. The District did a sweep and there were only 22 fraudulent enrollments; the rest were legitimate students. Overall for our enrollment we at 105% of our spring goal. FTES is 105% of our goal. In the fall we had 5,676; as of now we have 5,622. Our fall and spring are running very close</li> </ul>	Isabel O'Connor, VPI

For the year we are running 12,924 (our target for the year was 12,012).</li> <li>3) CCAP: Isabel thanked Dean Linda Hensley and Professor Gina Abbiate for doing the heavy lift of the CCAP program with several meetings and everyday monitoring. We received a couple of extra FTEF from the District for next year because we have pathways specifically designed for some of our high schools so that students can complete at least a certificate by the time they finish. CCAP is a program the District is interested in growing by offering more classes in high design for students who have traditionally not been college-bound. Dean Hensley does CCAP in addition to her other job.</li> <li>4) We have spent a lot of time last year with enrollment management planning and now we have a plan. Isabel thanked Professor Donna Budzynski who has been helping her launch the plan. A lot of the plan calls for coordination and cross-pollination; we tend to do a lot of work in scheduling but need to serve the students better. A pilot program called Platinum 5 which contextualized teaching for STEM majors in places like English was held. We also have credit for prior learning which is also an equity measure particularly for veteran students who come with a lot of knowledge and experience. Also Guided Pathways; Isabel stated she is thankful for the work that our coordinators do, Marisa Alioto and Howard Eskew. We have a lot of these initiatives that have in common a shared view of enhancing equity and student success. The Executive team have been discussing how to do some reorganization in the instructional division. VPI O'Connor stated we need to bring all of our strengths together and place them as the responsibility of a proposed Dean of Instruction position and this will be brought forward by President Hands to the District.</li> </ul>	
<ul> <li>b) Student Services Updates: Vice President of Student Services, Larry Maxey, gave the following updates:</li> <li>1) The District recently held a review of Financial Aid with all the colleges. It was a very detailed process; Larry, Saul, Vicki, and Pilar met today to go through some of the findings. There is a lot we have to accomplish in terms of supporting our students in financial aid, both locally at the college and throughout the entire district. This will be a slow-moving process toward getting to a point where we are operating optimally to accommodate all of our financial aid students.</li> <li>2) The Family Resource Center had a soft opening this week. They are accepting donations.</li> <li>3) They reviewed the District's Black Student Success taskforce's strategic plan for the support of black students across the district. It is very comprehensive work that included Dr. Gerace and they are reviewing it to see what the district's role is and the college's role.
