 a) Enrollment Report: Vice President of Instruction, Isabel O'Connor, presented the <u>enrollment report</u>. The FTES for 2/2/2020 is 5,685 (101.5% of target that was set at 5,600). Headcount is currently 20,883 (4.4% higher than Spring 2019) and is expected to reach 21,000+. b) Mesa Pathways: Mesa Pathways Co-chair Toni Parsons presented an update on <u>Mesa Pathways</u>. On January 27, 2020, a "soft reset" retreat was held which had 95 attendees, including 12 students. An evaluation survey was held and all feedback will be discussed at the next Mesa Pathways Committee meeting.
