PRESIDENT'S UPDATES a) District Updates:

President Pam Luster stated that the Certification of Interest to apply for the HIM Baccalaureate degree pilot program was sent this week. Tim McGrath presented the Pilot Program timeline. The next step in the process is the Request for Proposals which will be available on November 20, 2014. Tim shared that not all 15 of the pilot programs may be awarded – from our region only three have stated interest (Mesa College, Southwestern and MiraCosta.) An announcement of the Pilot Colleges selected will be given on January 21, 2015 and the programs must begin by 2017-18, although SD Mesa College would be prepared to begin with the first cohort by 2015-16.

President Luster announced that a Participatory Governance workshop will be held as part of the Board of Trustee regular meeting this Thursday, November 6, 2014. Participating from Mesa College is Rachelle Agatha, Terry Kohlenberg and Angela Liewen. The Student Equity plan will be presented to the Board of Trustees at this meeting.

b) New Process for Major Events (Rachelle Agatha): VPA Rachelle Agatha stated that a new process for major events will be piloted in Spring 2015. This form will be brought to a future President's Cabinet meeting.

Action Item: Consent approval vote for above major events. Motion: Rob Fremland; Second: Jennifer Cost. After discussion, the events were approved unanimously.

d) Special Presentation: Learning Communities Recommendation (Inna Kanevsky, Academic Affairs) Inna Kanevsky, Chair of Academic Affairs, presented their Position Paper on Learning Communities. Inna stated that they researched the practicality of the Learning Communities where they found some success, such as in the Hispanic and African American student populations, which seemed to benefit from these programs. The recommendation from Academic Affairs Committee was to continue the existing projects but they did not recommend implementing additional earning communities on campus, with the exception of the first year experience learning community program. The Position Paper also recommended an investigation into the benefits of basic skills prerequisites to achieve goals comparable with those of Learning Communities. The discussion that following included questions on the data used for research, such as two-year and four-year colleges and how the group defined "practicality. The discussion also included the request for Academic Affairs to use additional data and interview some of the Learning Community coordinators – the Position Paper is missing data on the SD Mesa College Learning Communities such as the Mesa Academy. Pam Luster asked if Academic Affairs and Academic Senate were willing to consider other voices left out of this research. Terry Kohlenberg commended the Academic Affairs for their research and stated that this topic will continue to be discussed at the November 17, 2014 Academic Senate meeting. President Luster then noted that the Position Paper would be tabled until after it is brought to the Academic Senate for a roundtable discussion to get additional feedback and that members of the President's Cabinet should bring this Position Paper to their constituents for their review and input.

Ashanti Hands added that the Student Equity Plan is moving forward with a survey on randomly selected classes at SD Mesa College which will enable us to identify salient needs, challenges and other issues on men of color at Mesa and to devise strategies that will be conducive to facilitate their success.
