c) District-Wide Updates (McGrath for Luster): Tim attended Chancellor's Cabinet and reported that the Chancellor has been in Sacramento working on the budget. She sent an email on April 15th which will provide additional information on the 2013-14 California budget as well as apportionment, student success funding and other issues.

2) COLLEGE-WIDE PLANNING

- a) Education Master Plan (Bri Hays): Bri stated that Jill Baker will return to the campus this Thursday and that they will be contacting schools and departments to begin focus groups using program review information already submitted. This summer additional data will be collected and put into a draft for review in early fall semester.
- **b) Mid-term Accreditation Report Forums:** Jonathan Fohrman reported that two forums have been scheduled to feedback from faculty for the accreditation report. He also added that evidence is still being compiled. Forum dates/times are: Friday, April 19, 2013, 10:30 a.m. 12:30 p.m., LRC 435; Wednesday, April 24, 2013, 4-6 p.m., LRC 435.

3) INSTRUCTION (Tim McGrath, VPI)

- a) Final Strategic IT Plan (Craft): Bill distributed copies of the plan to voting members of the President's Cabinet and the document was shown on screen. After the presentation a motion was made to accept this document and forward to President Luster for review and recommendation for approval *Motion: Laurie Mackenzie; Second: Susan Topham. - **b) Summer School**: Tim shared that a summer schedule is being prepared June 10 or 17 will be the start date (June 17 is being considered to allow time for high school students to register after their semester is over.)

4) STUDENT SERVICES (Julianna Barnes, VPSS)

a) Summer Student Services Staff Hours (Barnes): Julie stated that the student services staff will be on a 4/10 schedule this summer, Monday – Thursday, 8 a.m. – 6 p.m. beginning June 3, 2013, expect for administrative offices which will be open M-F

b) SB 1456 Update: Julie shared information on the ongoing changes with SB 1456 including a new funding formula which will start in the 2015/16 academic year which will be based on services that are provided to students. Students will then have to be given education plans, orientation and be assessed. Julie also commented on AB 585 – enrollment priorities. Jill Jansen attended hearings at the State Capital to advocate for community colleges and testified at the hearings.

5) ADMINISTRATIVE SERVICES (Daniel Gutowski, Interim VPA) a) Final Program Review Funding Request – Tentative BARC

Recommendations: Dan reviewed the document on screen and thanked Lynn Dang for her work on compiling the data. Purchase recommendations need to be given to the District Office by the deadline – next Tuesday they will be reviewed by BARC. Dan also shared some suggestions on how general areas could have scored higher in completing data for funding requests, including to be sure to express the need and link that need to student support and using the rubrics from program review.
