

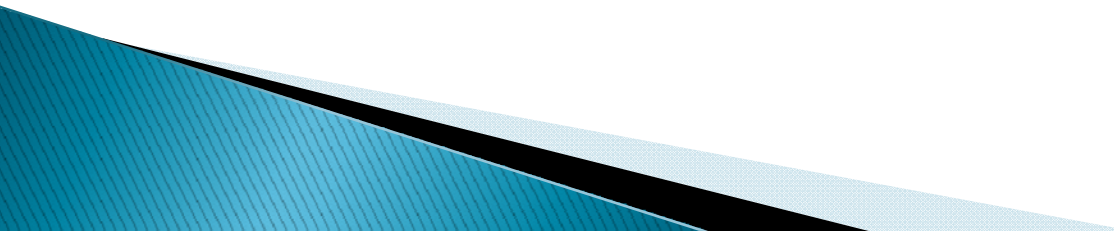

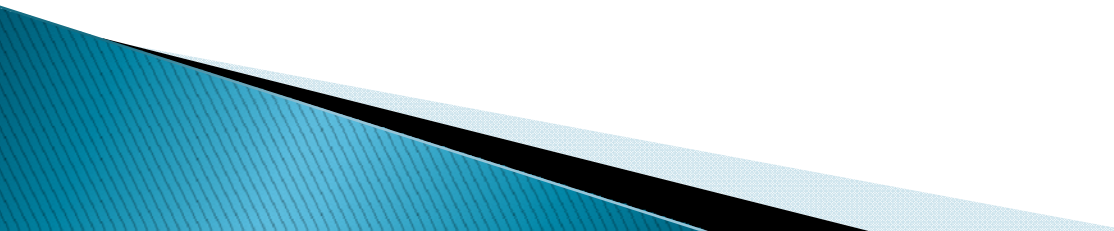

- ▶ On 16 January (compared to last fall)

◦ Headcount:	24,127	+2,338	11%
◦ FTES:	6,988	+737	12%

- ▶ Fill Rate: 87%

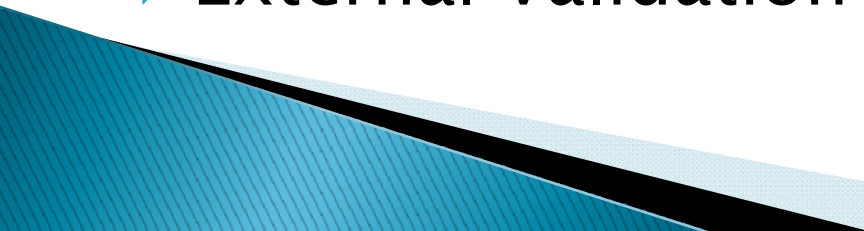
- ▶ Waitlisted Sections: 1,271 57%

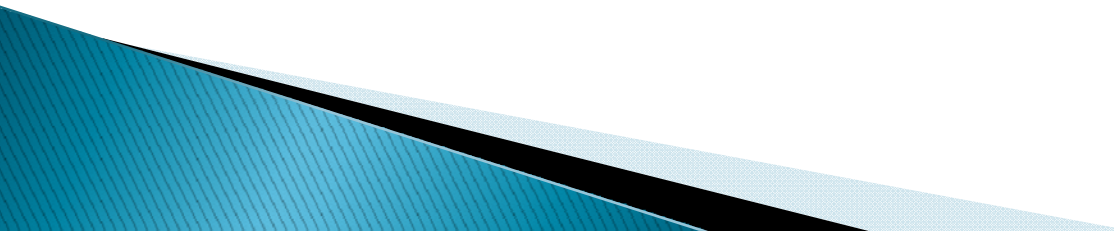
Accreditation Overview

2004 Recommendation #1 (of 9)

- ▶ Integrated Planning (1.1)
 - A fully integrated process for planning and resource allocation...grounded in data from program reviews
 - ...including data on student learning outcomes and assessment...
 - ...widely communicated...
 - ...evaluate the process regularly to assess the impact on institutional effectiveness.

- ▶ 2010 Report: This has not been fully addressed

2004 Recommendation #2 (of 9)

- ▶ Dialogue about Student Learning (1.2)
 - Strengthen dialogue about student learning...articulate specific goals with respect to the educational effectiveness of the college...
 - ...state the goals and supporting objectives in measurable terms...
 - ...the degree to which they are achieved can be determined...

- ▶ 2010 Report: This has not been fully addressed

- ▶ Institutional Research (1.3)
 - Develop and implement a plan to meet current and future needs for institutional research....

 - (District Recommendation)
 - Strengthen institutional effectiveness and foster a “culture of evidence”

- ▶ District Strategic Plan 1.5
 - (District Recommendation)
 - The district should formulate an overall strategic plan...
 - ...vision for the future development of the district, based upon extensive dialog among...[all parties].

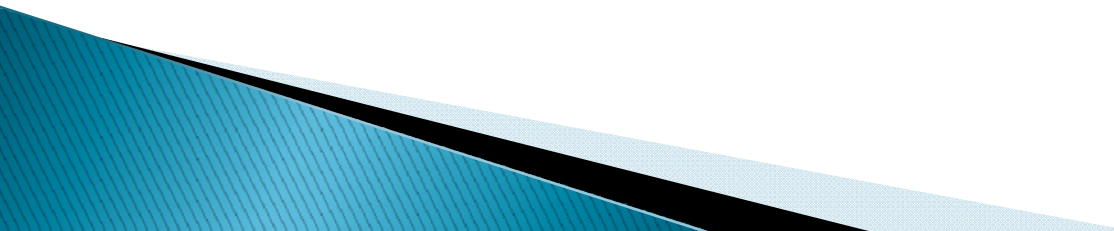

2004 Recommendation #6 (of 9)

- ▶ Student Learning Outcomes (3.1)
 - The college should complete the work on student learning outcomes...
 - and ensure that work on student learning outcomes is undertaken in all of the areas of the college in which the standards call for it.
- ▶ 2010: The work on this recommendation has not been completed

2004 Recommendation #7 (of 9)

- ▶ Diversity 3.2
 - (College & District Recommendation)
 - The district, in cooperation with the colleges, should explore new efforts and initiatives to identify and address the barriers that limit the diversity of their workforce and to ensure that faculty and staff reflect the rich diversity of their student body.

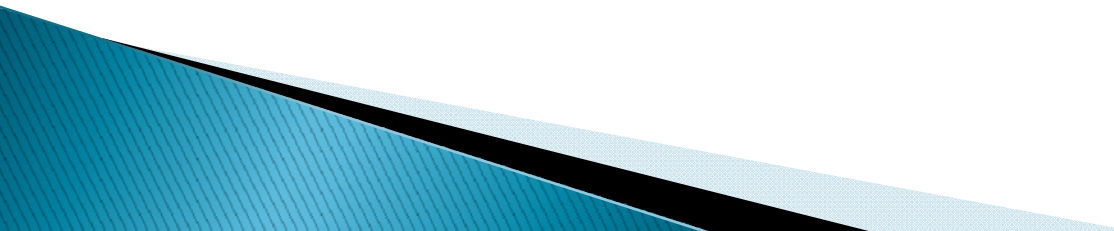

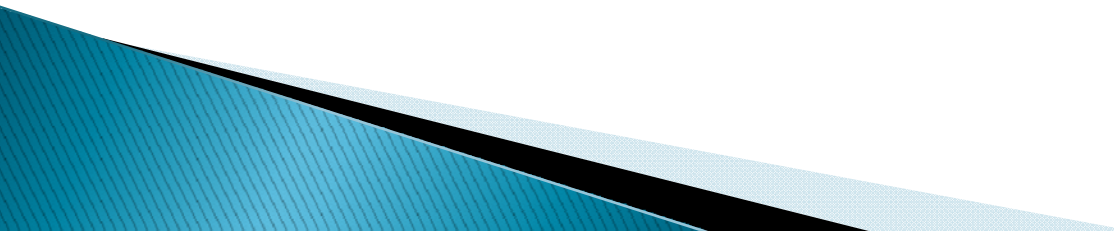

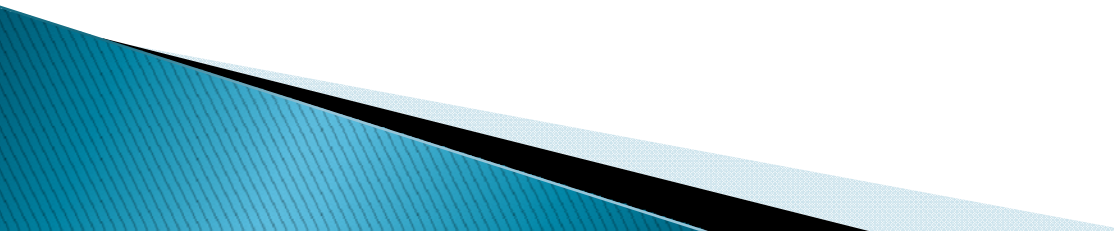
- ▶ Delineation of district/college functions (4.2)

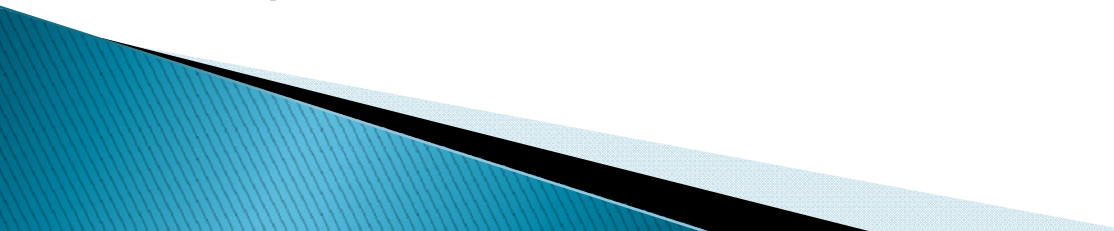
2010 Report: Commendations

- ▶ **Student Services Leadership** -- for expanding student participation in college governance and clubs.
 - ▶ **Library** -- for breadth of resources and services for remote users.
 - ▶ **College** -- for fostering a campus environment that welcomes and respects diversity and eliminates barrier to a diverse workforce; and for the Diversity Committee's website.

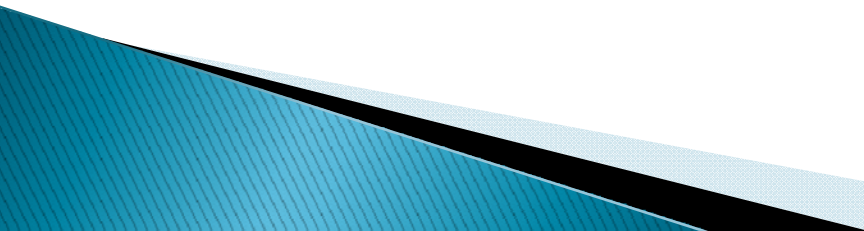
2010: Commendations (cont.)

- ▶ College and District -- for construction program and utilization of Prop S & N resources
 - ▶ College -- for re-energizing student involvement and for innovation in dealing with budgetary constraints
 - ▶ Board of Trustees -- for annual self-evaluation process
 - ▶ BOT, District, and College Leadership -- for fiscal oversight and management

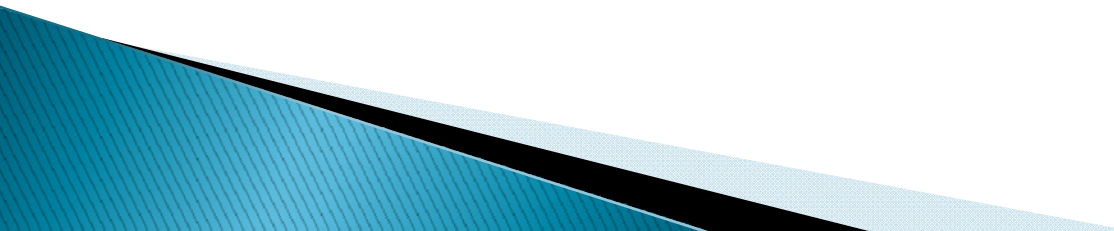
2010 College Recommendation #1

- ▶ Develop and implement an integrated process that links all components within program review and ensures that an integrated planning process directs resource allocation. The college should:
 - Develop measurable goals and objectives and integrate data on student achievement into the planning and resource allocation process;
 - Develop an ongoing and systematic cycle that links program review, planning, resource allocation and re-evaluation based on the analysis of quantitative and qualitative data;

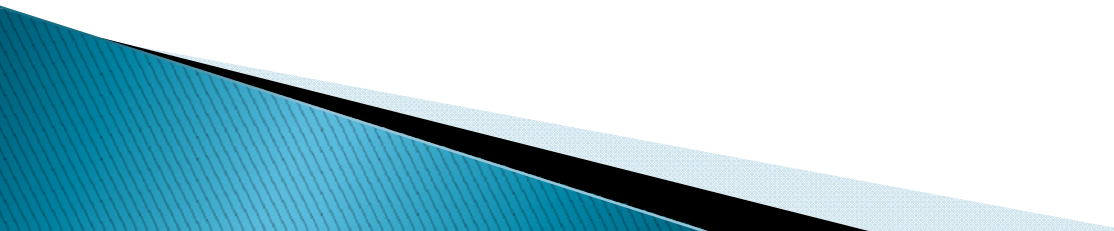
2010 Recommendation #1 (cont.)

- ▶ The college should (cont.):
 - Demonstrate that the allocation of resources considers the needs and priorities of the college based upon its mission and goals;
 - Demonstrate that resource allocation leads to the improvement of institutional effectiveness; and,
 - Communicate the results to appropriate constituencies.

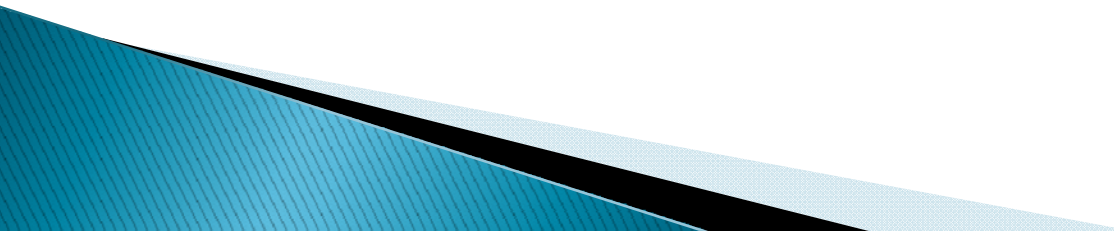
2010 College Recommendation #2

- ▶ The College should accelerate the development and assessment of course level Student Learning Outcomes;
 - ▶ and, in order to meet the 2012 deadline,
 - ▶ the team recommends that the college assess and align SLOs at the course, program, and institutional levels, and use the results to make improvements.

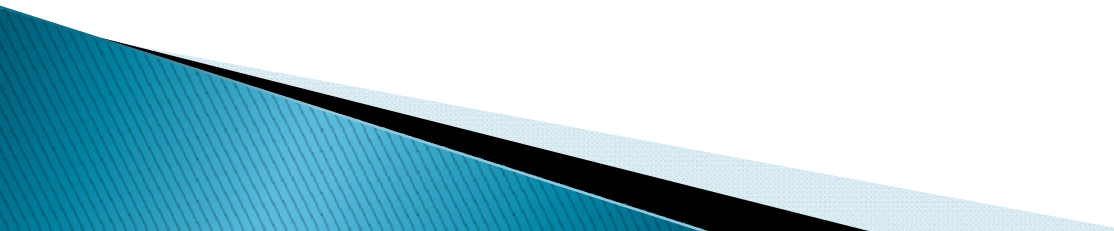
2010 College Recommendation #3

- ▶ The College should improve communication concerning the process used for technology planning to all campus stakeholders, develop a method to engage non-users in technology and also secure stable funding sources for technology resources.
- 

2010 College Recommendation #4

- ▶ The College should develop an adequate system for program review of Administrative Services which integrates planning and resource allocations and assures the linkage between program review and resource allocation.
- 

2010 District Recommendation #1

- ▶ The team recommends that the District's Board of Trustees develop a policy to address the selection and evaluation of college presidents.

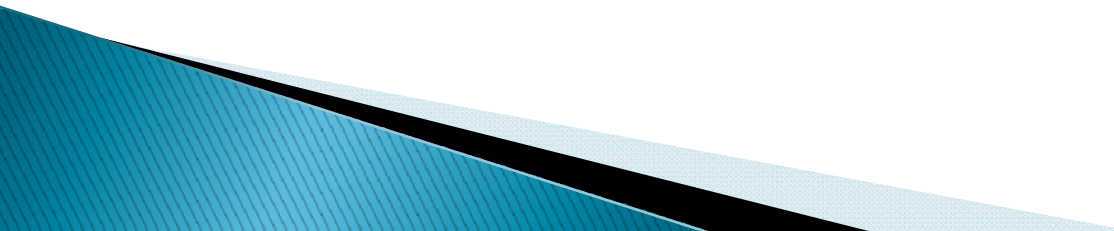

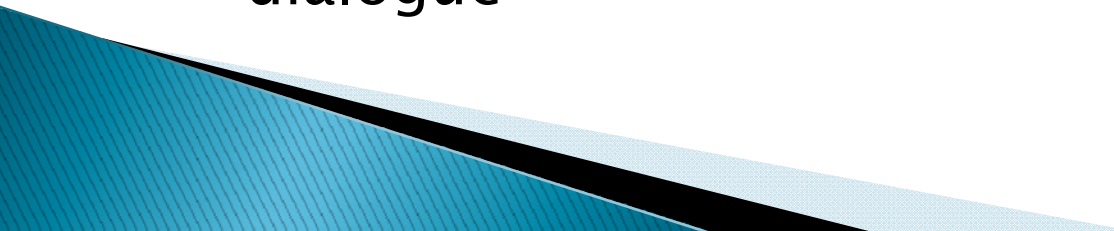

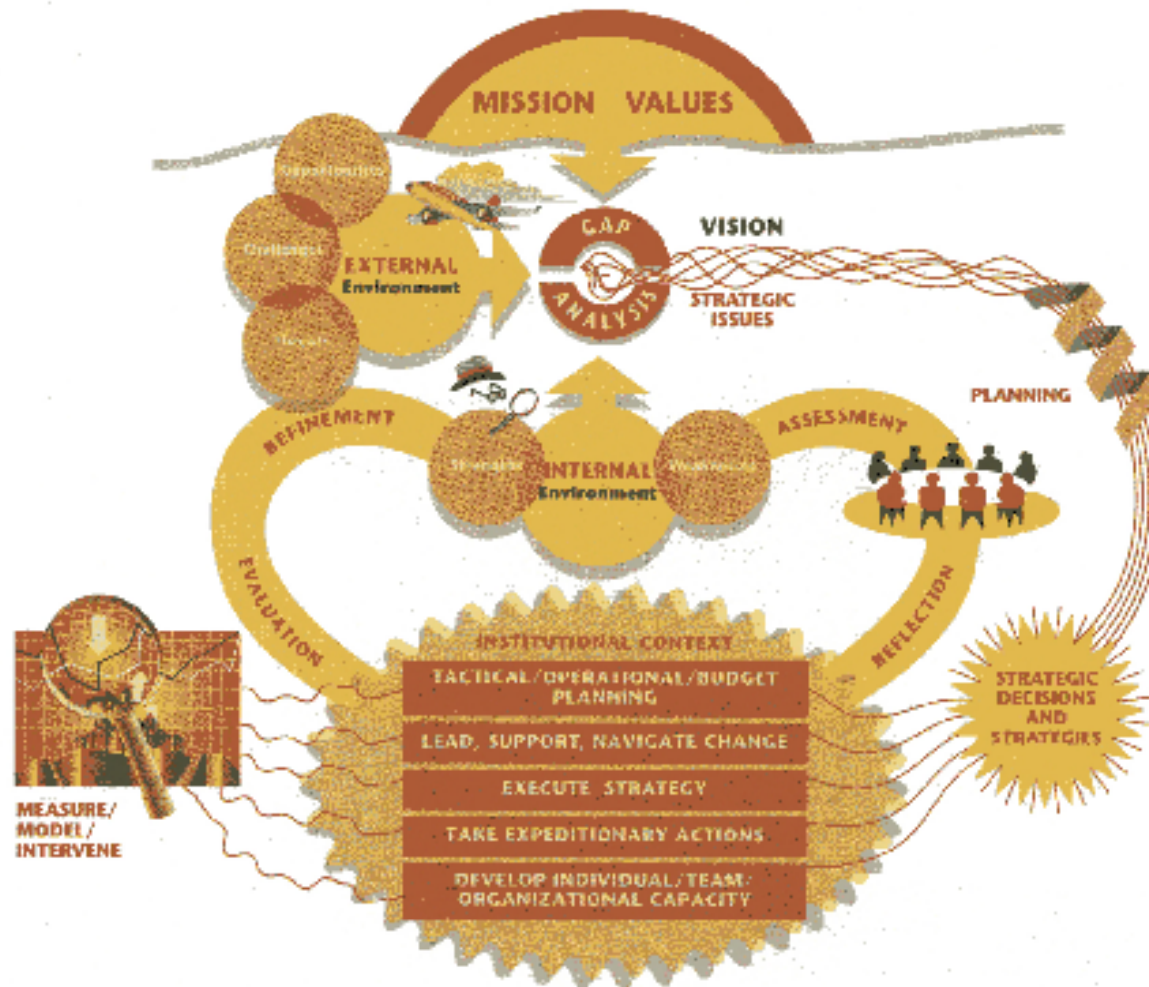
The Process

- ▶ Committee began meeting summer 2010 to begin next steps in strategic planning
 - ▶ Committee decided to use an internal consultant to facilitate shared reading and dialogue to create a common understanding of strategic planning:
 - Theory: Literature review informed the reading
 - Application: Used the context of Mesa governance, processes, and culture to provide the lens for dialogue

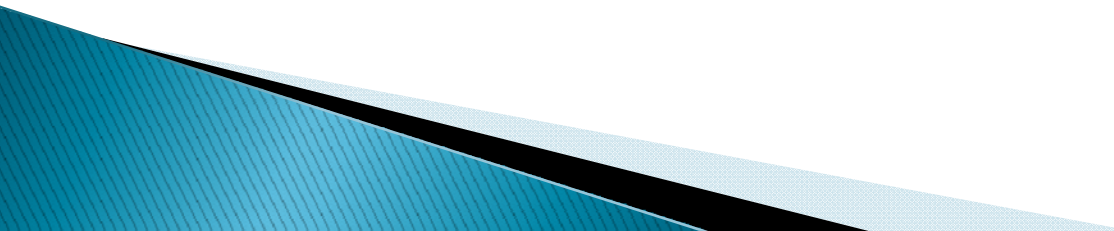

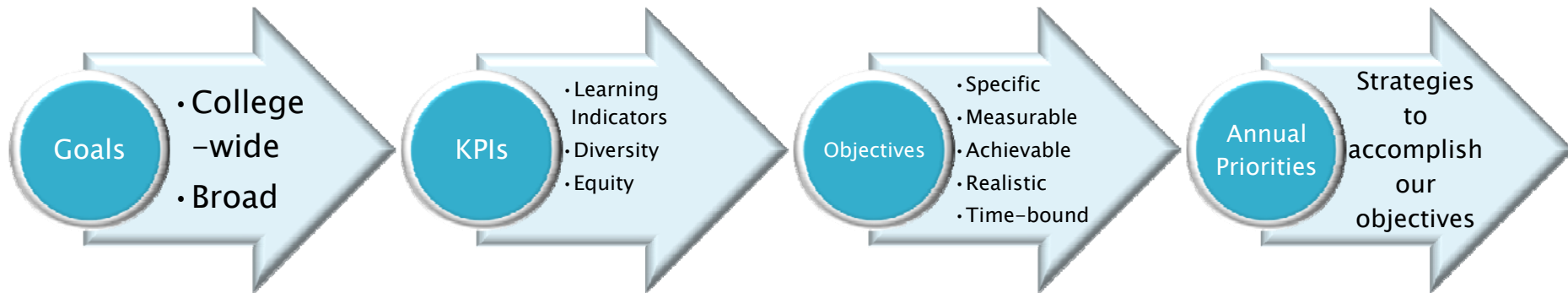

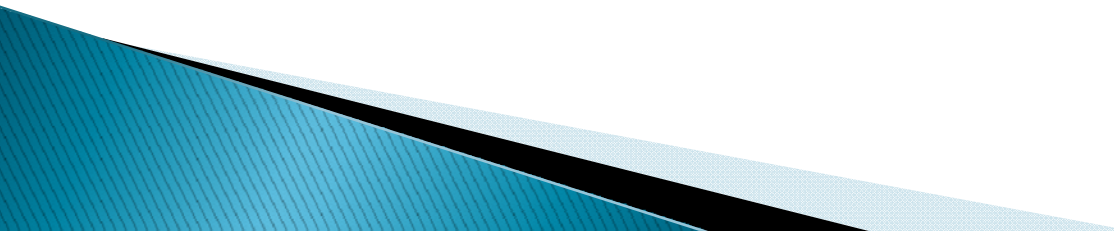


(5) Strategic Planning: Integrated Planning Proposal

Guiding Principles

- ▶ Build upon existing practices & traditions
 - ▶ Honor shared governance
 - ▶ Reduce workload on Faculty / Staff by simplifying & eliminating redundant practices
 - ▶ Integrated planning should:
 - Coordinate previously disjointed planning efforts
 - Link long-term goals and short-term planning
 - Link allocations to goals
- 

Pre-Existing Planning Processes

▶ Strategic Planning

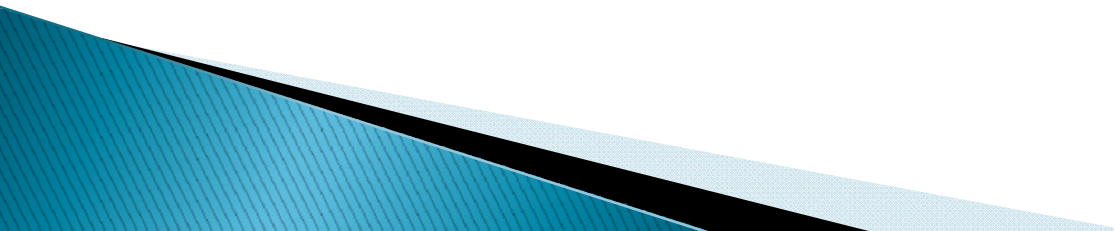
- President's Cabinet / Academic Affairs role
- Strategic Planning Committee:
 - since 2008 (on-and-off)
 - revived Summer 2010
- Inadequate connection to other planning processes

▶ Program Review

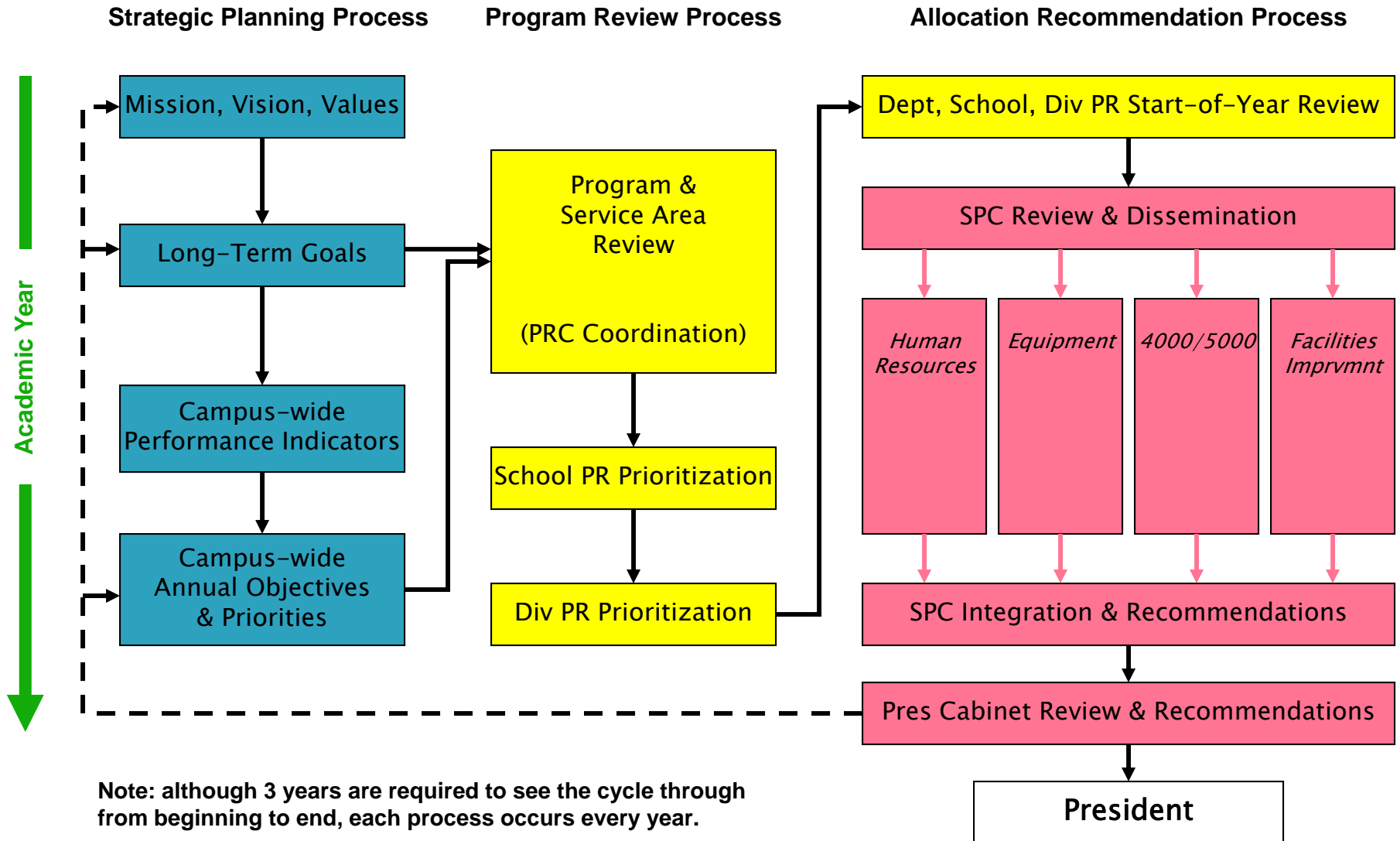
- The 'heart' of planning at SDMC
 - Inadequately tied to Strategic Planning or Allocation
 - Complex & time-consuming
- 

Pre-Existing Planning Processes (cont.)

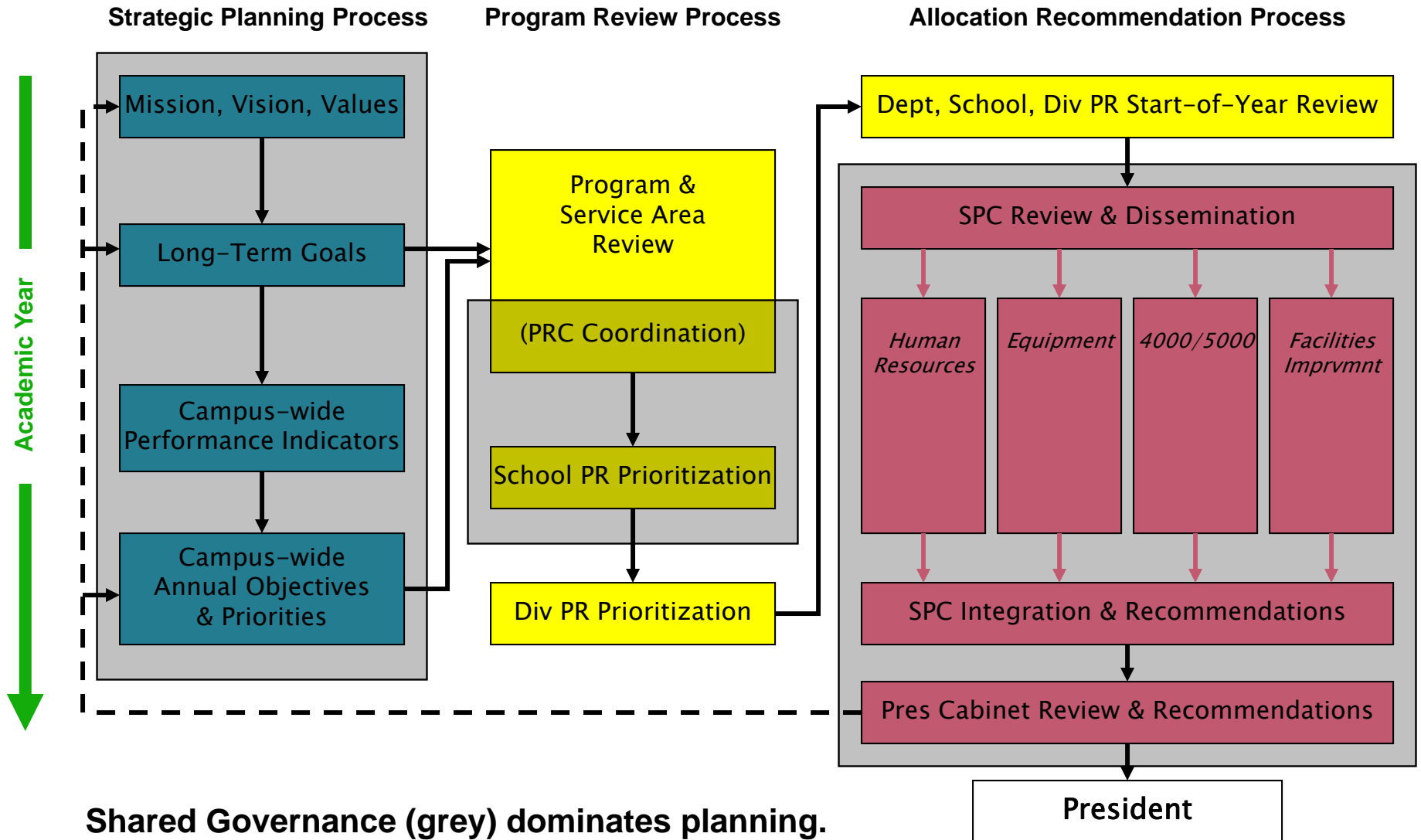
▶ Allocation Planning

- 4 separate resource 'silos' (not integrated)
 - Require 4 separate applications
 - Committees review & recommend:
 - Faculty Positions (Faculty Prioritization Committee)
 - Equipment (Perkins Committee; Deans' Council)
 - 4000 / 5000 (Deans & VPs)
 - Facilities Improvement (Facilities Committee)
 - Allocations not linked to campus goals

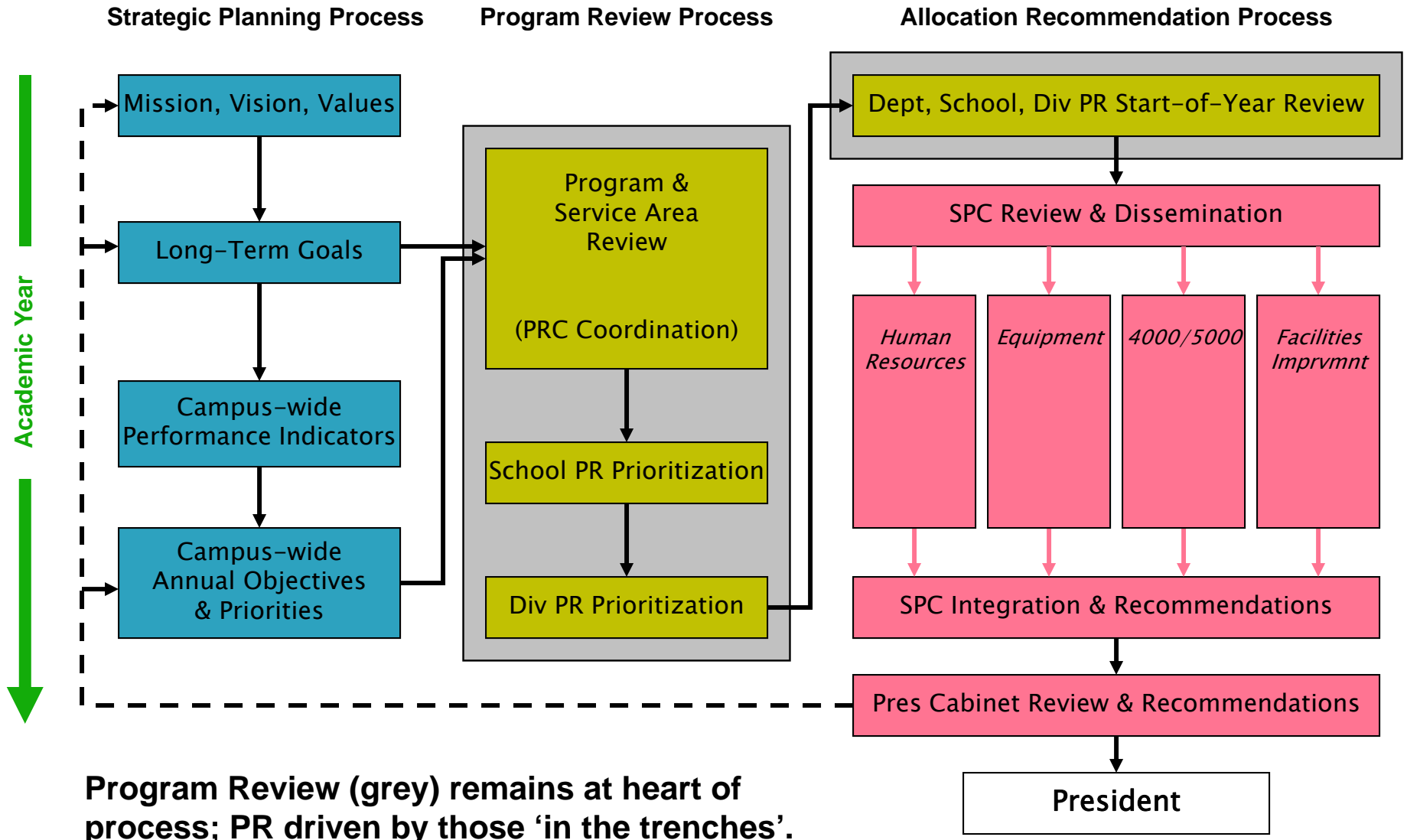
SDMC Integrated Planning (Proposed)



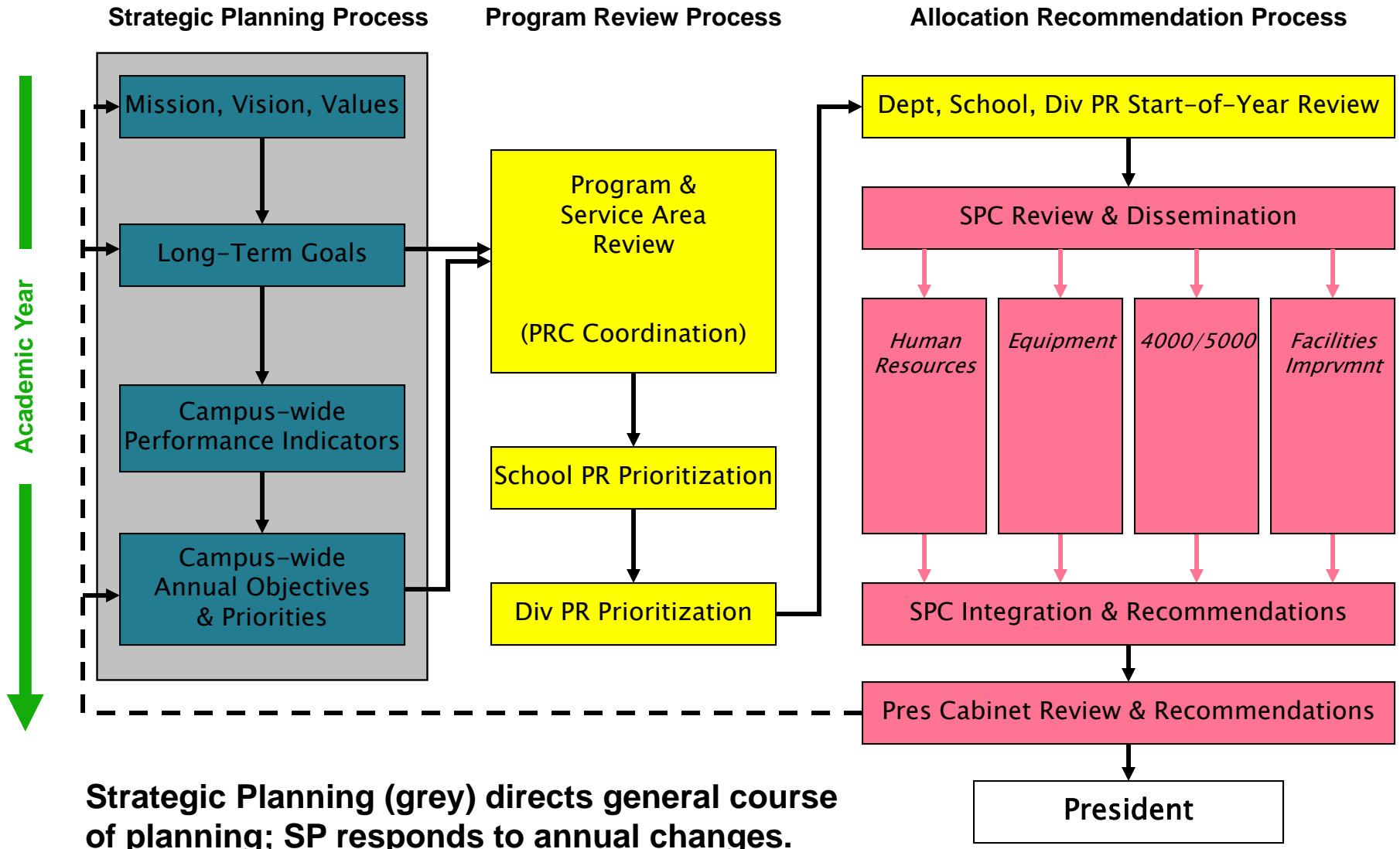
SDMC Integrated Planning (Proposed): Role of Shared Governance



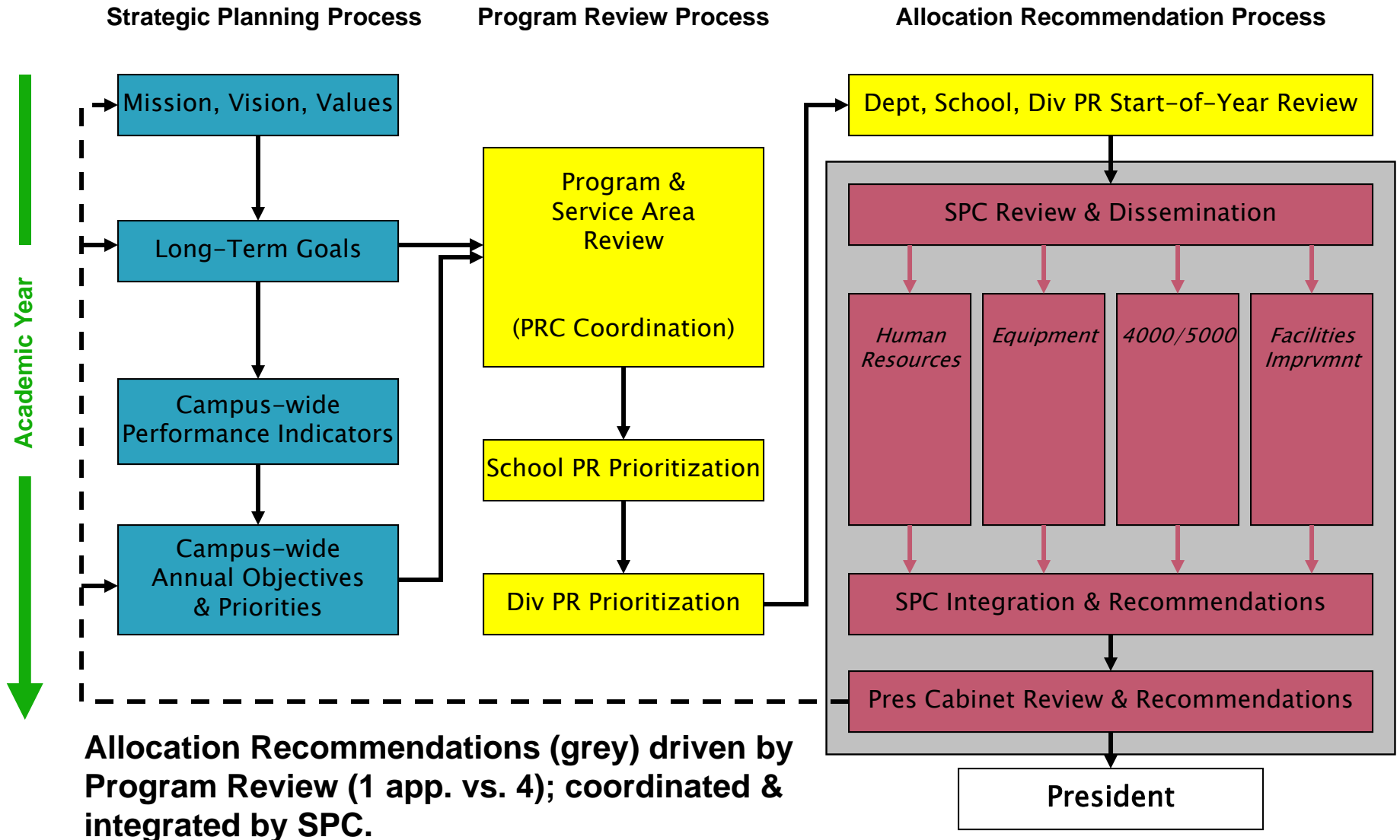
SDMC Integrated Planning (Proposed): Role of Program Review

SDMC Integrated Planning (Proposed): Role of Allocation Recommendation Process



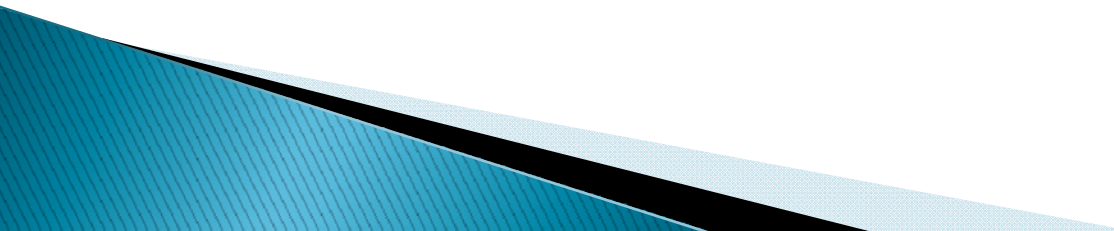
