## IPEI Guided Pathways Workshop

#### Team Takeaways

There is no specific concrete definition or process for Guided Pathways that's being promoted and for this reason it's important that we come together as a college to provide/create that definition/process.

Classified are essential to the process of envisioning and implementing strong student pathways.

We are embarking on a journey (journey versus destination) at this moment in time and that all stakeholders need to be a part of the conversation. It will take cross-disciplinary and Student Services/Instruction collaboration.

Each college can proceed down their own unique "Guided Pathway" to meet student needs. That though there are some general parameters that at the end of the day we are responsible for doing this work together.

We already have the components of Guided Pathways. Now we need to take an institutional evolution to rethink (from the student perspective) how we deliver and provide curriculum, services and information to students.

This is meaningful, tough and time-consuming work. We need to be open with no assumptions, asking hard questions and being vulnerable.

Key elements are cost, communication and coordination.

My takeaway is some ideas of how colleges began the conversation with the faculty. In particular, Sierra College; how they sat down to see if a student can complete their programs in "two years." Lastly, "Resistance" is for real, continual conversation, dialogue, and validation begins movement. For some colleges this idea of Pathways has been 5 years in the making.

My takeaway was that we are embarking on a journey (journey versus destination) at this moment in time and that all stakeholders need to be a part of the conversation. It will take cross-disciplinary and Student Services/Instruction collaboration.

I personally think we need a four person team with 100% dedication to this (faculty, admin, classified and a student – yes pay a student to do this!)

Mesa's Guided Pathways = our commitment to Student Success & Equity. We have been doing the work and will now have resources to do it with more intentionality

Instruction and Student Services (esp. Counseling) need to talk more.

We need to toss around lots of "what ifs", and try to calm the fears that programs will lose their integrity.
