Important Dates

As you begin to make decisions, we encourage you to speak with faculty in your majors, transfer institutions, licensing agencies and counselors. **Plan ahead, counselor schedules fill quickly.**

May 8, 2020 Dead

Deadline to drop and receive a Withdrawal (W). All Withdrawals as of May 8th will automatically be adjusted to an Excused Withdrawal (EW). The EW is excluded from probation and disqualification calculations and is not included in the number of allowable "takes" of a course.

May 8, 2020

Deadline to change the grading option for a class to Pass/No Pass. For many classes, this may be done online through mySDCCD;



However, for some classes you will need to complete the <u>Petition for P/NP for Courses Not Approved</u>. It is highly recommended that you consult with a counselor prior to selecting this option for courses not approved.

Summer and Fall 2020

All classes for **Summer 2020** will be fully online or remote. There will not be any on-campus/in-person classes. It is still unknown at this time if **Fall 2020** classes will be able to be scheduled on-campus, in-person, or hybrid.


