### 2022-2023 GUIDED PATHWAYS – ONE TIME FUNDS

#### LEGISLATIVE MANDATE

In the 2021-22 Assembly Bill 132 Postsecondary education trailer bill, the Legislature approved \$50 million in one-time funding to "support the continued implementation of a guided pathways program." The Chancellor's Office will distribute the one-time funding in three phases to ensure colleges integrate the Guided Pathways funding and framework into their structures and practices equitably.

### GUIDED PATHWAYS PROGRAM PHASED FUNDING APPROACH

The Chancellor's Office will distribute this one-time funding in three phases per the apportionment schedule of the 2022-23 Fiscal Year. Total funding is \$47,500,000. **SDCCD** will receive \$1,381,160. The release of funds for each phase has separate document submission requirements.

#### PRIORITY AREAS OF GP FUNDS

For this round of funding, colleges are asked to prioritize GP Integration with the following efforts:

- SEA Program
- Associate Degrees for Transfer (ADTs)
- Zero Textbook Cost (ZTC) Programs
- Adult Education
- Strong Workforce

#### PHASE I—ACKNOWLEDGEMENT OF ASSURANCES

Phase I funding of \$28,500,000 (60% of the total program funding) will be distributed in August 2022. As a condition of receiving Phase I funding, colleges must submit an Acknowledgement of Assurance by September 30, 2022.

The Acknowledgement, asks colleges to certify that they agree to comply with all the program requirements articulated in the Report and commit to the continued integration of the equitable Guided Pathways framework into institutional structures and practices as required by the Legislature.

#### PHASE 2 – (PI) GUIDED PATHWAYS 2022-2026 WORKPLAN

Phase 2 funding of \$15,200,000 (32% of the total program funding) will be distributed in February 2023.

As a condition of receiving Phase 2 funding, colleges shall submit their Guided Pathways 2022-26 Workplan by March, 2023. The CCCO is still developing the workplan content and structure.

### PHASE 3 (P2) – REPORT TO BE ANNOUNCED

Phase 3 funding of \$3,800,000 (8% of the total program funding) will be distributed in the Second Principal Apportionment (P2), June 2023.

The Chancellor's Office will release allocation and reporting details following an analysis of the Phase 2 required workplans.

#### ACKNOWLEDGE OF ASSURANCE

To receive the GP Funds, colleges must submit a verification that they will comply with the program requirements and commit to further institutionalizing Guided Pathways into structures and practices in NOVA by September 30, 2022.
