2025 – 2026 Reporting Bachelors Degree

You have indicated on your 2025 - 2026 Free Application for Federal Student Aid [FAFSA] that you have or will have a bachelor's degree by or before July 1, 2025 or that you will be a Graduate/Professional student during the 2025 - 2026 academic year.

Before we can continue processing your application, the Financial Aid office will need clarification, as having a bachelors degree will disqualify a student from receiving most forms of financial aid based on the San Diego Community College District Satisfactory Academic Progress policy.

If you have not earned a bachelors degree or higher prior to the 2025-26 academic year, complete the San Diego Community College District "Change of Degree Declaration" Form on the second page of this document and submit it to the San Diego Mesa College Financial Aid Office along with copies of all academic transcripts from your prior institutions. You may submit the form <u>online here</u>, in-person, by mail, or by fax at (619) 388-2824 so that the Financial Aid Office can determine what corrections, if any, may be needed to your FAFSA.

If you have already earned a bachelors degree or higher, even if it is from a foreign country, you may still be eligible to receive aid. However, you must first submit a Satisfactory Academic Progress Appeal, which can be found on the Forms and Petitions section of the Financial Aid website.

Please note, California residents are considered for the California College Promise Grant (CCPG) without needing to appeal. A successful appeal would allow students to be considered for Federal Direct Student Loans, so long as students have not already exceeded their aggregate loan borrowing limits. Federal Work-Study may also be available; however, funding limits apply. Unfortunately, gift aid, including the Federal Pell Grant and Cal Grant are not available to students who have previously earned a bachelors degree.
